13	WHEREAS, a man of steadfast diligence who wore many
14	hats, Representative Wheeler was a passionate servant and
15	leader throughout his home state of Alabama, to the Republican
16	Party, and at his alma mater, The University of Montevallo;

18	WHEREAS, Representative Wheeler was born on January
19	11, 1950, in Jemison, Alabama; and
20	WHEREAS, he earned a Bachelor's Degree in Accounting
21	from The University of Montevallo in 1972 and a Master of

23	1976; from 1972 to 1988, he held various management and staff

3	Public Service Commission; from 1988 to 1993, he served as the
4	Manager of Government and Federal Affairs for Alabama Power in
5	Washington, D.C.; altogether, he worked for Alabama Power for
6	29 years; and

WHEREAS, in 2008, Representative Wheeler was appointed to The University of Montevallo Board of Trustees by Governor Bob Riley for a term ending in 2032; in addition, he served as Chair of the Personnel Committee and Vice Chair of the Board of Trustees and Executive Committee; in April 2009, the David W. and Diane R. Wheeler Endowed Scholarship was created at The University of Montevallo; and

WHEREAS, in 2018, Representative Wheeler was elected to his first term of office, serving House District 47 in the State of Alabama; he served as Treasurer of the Alabama Republican Party and as past Chairman of the Jefferson County Republican Party; he was also a member of the Jefferson County Republican Executive Committee, the Alabama Republican Steering Committee, and the Alabama Republican Executive Committee, and he was past Treasurer of the Mid-Alabama Republican Club; most recently, he served for three years as the President of Vulcan Termite and Pest Control, Inc.; he was a member of All Saints Episcopal Church in Homewood, Alabama, and of the Hoover Country Club; and
