COMMENDING OFFICER ZACK TUTTEN AS A NOMINEE FOR THE 2017 ALABAMA LEGISLATIVE MEDAL OF HONOR FOR LAW ENFORCEMENT.

WHEREAS, it is with highest commendation that we recognize Officer Zack Tutten of the Lincoln Police Department as a nominee for the 2017 Alabama Legislative Medal of Honor for Law Enforcement, Alabama's highest law enforcement award for extraordinary courage in the line of duty; and

WHEREAS, on the morning of May 28, 2016, Officer
Zack Tutten responded to a domestic assault call at the
Discount Food Mart within the police jurisdiction of Lincoln,
Alabama; the male aggressor had already departed when Officer
Tutten arrived on the scene; Officer Tutten immediately called
for paramedic assistance for the female assault victim; while
the paramedics were treating the victim and he was preparing a
report, Officer Tutten noticed the male suspect drive slowly
through the parking lot of the store; Officer Tutten quickly
exited the store, jumped into his patrol car, and drove out of
the parking lot and onto the highway behind the suspect's
vehicle; the suspect drove through the other entrance of the
store parking lot and pulled right in front of the store's
glass entry doors; upon seeing that the suspect had returned,
the store clerk locked the front door; Officer Tutten drove

back into the drug store parking lot and pulled behind the suspect's vehicle; the suspect jumped out of his car holding a pistol grip shotgun and pointed it at everyone inside as he attempted to regain entry into the store; Officer Tutten commanded the suspect to drop the weapon; the suspect turned and pointed the shotgun directly at Officer Tutten, forcing him to fire his weapon at the suspect who was fatally wounded; and

WHEREAS, placed in a life-threatening situation and without a moment's hesitation, Officer Zack Tutten placed himself in the line of peril and stopped the individual from killing or harming at least a half dozen people including the two store employees, the original assault victim, two Lincoln firefighter/medics, a civilian shopping in the store, and customers in the parking and gas pump areas of the store; and

WHEREAS, Officer Zack Tutten demonstrated immense courage, diligence, and quick response in a life-threatening situation; his loyalty and unwavering commitment to protect and serve the residents of Lincoln, Alabama, were evidenced by his quick and proper response in protecting the lives of others; and

WHEREAS, Officer Zack Tutten epitomizes the qualities of those who serve and protect, and he is truly deserving of this distinguished nomination for the Legislative Medal of Honor for Law Enforcement; now therefore,
