WHEREAS, on July 17, 2013, Deputy Mulkin and Deputy Jason Orr were off duty and in plain clothes traveling along I-65 south near Fultondale to an appointment in Deputy Orr's assigned county vehicle when they were stopped in traffic due to an accident; a citizen approached them and informed them of a medical emergency in a vehicle behind them; and

WHEREAS, Deputy Orr positioned his vehicle to block traffic; Deputy Mulkin and Deputy Orr were advised that the man had possibly suffered a heart attack; the deputies removed the man from the car, noticed that he was not breathing, and they could not discern a pulse; they began to render assistance, including CPR, which they continued until paramedics arrived; and
