11 WHEREAS, highest commendations are herein proudly
12 presented to Kent Chambers for outstanding professional
13 achievement and longtime service to Bob Jones High School;
14 since 1986, he has been an integral part of the faculty,
15 teaching various levels of math and coaching several sports;

18 High School, Coach Chambers has served as Assistant Athletic
19 Director, has coached volleyball for three years, girls
20 basketball for six years, swimming for one year, and has
21 coached softball for 28 years; he has a winning career record
22 of 863-591-6, with 19 winning seasons, 12 trips to the state
23 playoffs, and over 50 of his players have signed college
24 scholarships; and

25 WHEREAS, Coach Chambers has served on various
26 district level committees for the Madison City Schools; he
27 participated in the design team for James Clemens High School,

1 and has been nominated for Teacher of the Year three times; he
2 is involved in community activities and organizes the
3 Christmas Angels for all the athletic teams; he organizes the
4 softball team's participation in Field of Dreams, donations
5 for Thanksgiving and Christmas, and the Breakfast Buddies
6 mentoring program; and

7 WHEREAS, Coach Chambers has served on the Alabama
8 High School Athletic Association softball committee since
9 1997, and is a member of the AHSAA All-Star Week Coaches
10 Clinic planning committee; he coached the 2005 and 2006
11 Tourney Sport Camps in Hawaii, was 2005 Instructor at Auburn
12 University's summer softball camp, 2007 Instructor at The
13 University of Alabama's summer softball camp, was elected in
14 2007 to represent Alabama at the National Federation of High
15 Schools Youth Leadership Conference, and in 2008-2009 he was
16 named AHSAA State Athletic Director of the Year; and

17 WHEREAS, Coach Chambers has made a difference in the
18 lives of countless students and families; a conscientious,
19 committed, and caring teacher and counselor such as Coach
20 Chambers, who meets the challenges in the school environment
21 with professionalism and dignity, is deserving of the
