1 ENROLLED, House Joint Resolution, 2 ESTABLISHING THE ALABAMA SPORTS WALL OF HONOR. 3 4 5 WHEREAS, sports historically have made a tremendous impact in the State of Alabama bringing high honor, acclaim, 6 7 economic development, and in many cases, worldwide notoriety; 8 and WHEREAS, Alabama has a rich heritage and a powerful 9 10 legacy of sports achievement which inspires youth to continue 11 the dynamic athletic prowess achieved by legendary figures 12 that have hailed from towns large and small all over this 13 proud and patriotic land; and 14 WHEREAS, sports inspire and contribute to the concept of individual excellence with teams being made up of 15 16 exceptional individuals who are well-disciplined, 17 well-rounded, and set high goals; and 18 WHEREAS, Alabama Sports Festival has, for 19 approximately 30 years, encouraged the youth of Alabama to 20 participate in sports for personal enrichment and to 21 perpetuate the sports legacy that is unique to Alabama. 22 Additionally, Alabama Sports Festival has offered many other 23 programs which strengthen the resolve of students all over 24 Alabama to avoid the pitfalls of drugs, smoking, and other social ills; and 25

1 WHEREAS, the Governor of Alabama, the Alabama 2 Legislature, and the Alabama Governor's Commission on Physical 3 Fitness, have consistently supported the Alabama Sports 4 Festival programs allowing the youth in Alabama an opportunity 5 to participate in sports activities which contribute to the 6 overall well-being and strength of Alabama; now therefore,

BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH 7 8 HOUSES THEREOF CONCURRING, That there is hereby created the 9 Alabama Sports Wall of Honor as an activity of the Governor of 10 Alabama, the Alabama Legislature, Alabama Sports Festival, and 11 the Governor's Commission on Physical Fitness, with the administrative and financial responsibility being borne by 12 13 Alabama Sports Festival. Portraits of the honorees, 14 commissioned by Alabama Sports Festival, will be permanently 15 displayed on the Alabama Sports Wall of Honor which shall be 16 located in an appropriate area inside the Alabama State House. 17 Each year, during the opening ceremonies of the Alabama Sports 18 Festival, additional honorees will be officially inducted.

BE IT FURTHER RESOLVED, That the inaugural induction ceremony of the Alabama Sports Wall of Honor shall take place at seven p.m., Friday, June 24, 2011, center stage at the Birmingham-Jefferson Civic Center Arena. This event will be telecast live on statewide television and the honorees will be introduced and recognized for their achievements.

BE IT FURTHER RESOLVED, That the inaugural class of 1 honorees shall consist of the head football coach of the 2 3 University of Alabama, Nick Saban, in honor of the Crimson Tide's 2009 undefeated 14-0 season which resulted in a BCS 4 5 National Football Championship; Auburn University head football coach Gene Chizik, in honor of the Tigers' 2010 6 undefeated 14-0 season which resulted in a BCS National 7 8 Football Championship. Additional honorees will be the 2009 Heisman Trophy winner, Mark Ingram of the University of 9 10 Alabama and the 2010 Heisman Trophy winner, Cameron Newton of 11 Auburn University, the first ever back-to-back Heisman Trophy 12 winners from the same state. Also, the 1971 Heisman Trophy 13 winner, Pat Sullivan of Auburn University and the 1985 Heisman 14 Trophy winner, Bo Jackson of Auburn University will be 15 inducted.
