3 EXTENDING THE LIFE OF THE LIEUTENANT GOVERNOR'S
4 COMMISSION ON PUBLIC-PRIVATE PARTNERSHIP PROJECTS, APPROVING
5 RECOMMENDATIONS OF THE COMMISSION, AND LIMITING EXPENDITURES.

7 WHEREAS, on May 18, 2008, the Legislature of the
8 Great State of Alabama, with both houses thereof in agreement,
9 established the Lieutenant Governor's Commission on
10 Public-Private Partnership Projects, SJR 119, Act No.
11 2008-478. The commission was established to study
12 public-private partnership projects in other jurisdictions and
13 their potential application within Alabama, and to report its
14 findings, conclusions, and recommendations for proposed
15 legislation to the Legislature no later than the fifth
16 legislative day of the 2009 Regular Session, whereupon the
17 commission would stand dissolved and discharged of any further
18 duties and liabilities; and

19 WHEREAS, the leadership of the commission in
20 accordance with the recommendations contained in the 2009
21 commission report did meet with persons deemed to have
22 expertise and experience in P-3 surface infrastructure project
23 initiatives in both the domestic and international markets;

1 WHEREAS, the commission leadership feels it is in
2 the best interest of the commission objectives to conduct
3 informational briefings by experienced P-3 experts to the
4 commission at large as well as other relevant persons
5 including interested members of the Alabama Legislature; now
6 therefore,

7 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
8 HOUSES THEREOF CONCURRING, That the Lieutenant Governor's
9 Commission on Public-Private Partnership Projects continue
10 with implementation of the recommendations included in its
11 original report to the Legislature and that the commission be
12 extended until the fifth legislative day of the 2011 Regular
13 Session of the Alabama Legislature.
