WHEREAS, it is with an overwhelming sense of loss that we mourn the death of Mr. Walter Ryland Byars, Jr., of Montgomery, Alabama, on January 23, 2014, at the age of 85 years; and

WHEREAS, a native of Birmingham, he received his
Bachelor of Science Degree in Commerce and Business
Administration in 1948, Bachelor of Laws Degree in 1952, and
Juris Doctor Degree in 1969, all from The University of
Alabama, where he became an active member of Sigma Chi
Fraternity and served with dedication over the years in many
capacities, receiving the first Lifetime Service Award of Iota
Iota Chapter and selected a Significant Sig by Sigma Chi
International in 2012; and

WHEREAS, he served with distinction in the United States Navy from being commissioned an Ensign in 1948 until his honorable discharge with the rank of Lieutenant in October 1966; and

WHEREAS, Mr. Byars actively practiced law for more than 60 years, commencing in Troy in 1953, then joining the Legal Department of Southern Bell in Atlanta and Birmingham, and reentering private practice in 1968 in Montgomery with the
