6	WHEREAS, with highest tribute and deepest		
7	appreciation, we honor the lives of Anthony Robinson, Jr., and		
8	his cousin (brother) Christopher "C.J." Boykins who tragically		
9	died in a motor vehicle accident on September 1, 2013, in		
10	Marengo County; and		
11	WHEREAS, Anthony was an outstanding athlete while a		
12	student at Linden High School and had just begun the next step		
13	in his career as a member of the University of West Alabama		
14	Football team when he died at the young age of 19; and		
15	WHEREAS, the consensus of the Linden community is		
16	that Anthony was a great kid who led by example, and as noted		
17	by a sportswriter "class on and off the field, whether it be		
18	football, basketball, track or just life"; and		
19	WHEREAS, Anthony's college football coach stated		
20	that "Very rarely does a freshman impact a team right away,		
21	but Anthony had already had a tremendous impact on our		
22	football team in a very short time. He was a great player, but		
23	an even better person"; and		
24	WHEREAS, C.J. died at the tender age of 12 while a		
25	student at the Demopolis Middle School, where the principal		

1 said of him, "C.J. was outgoing, and he was very popular and 2 he was known as a people person and he loved his family and 3 sports, had a big heart, and was eager to learn new things"; 4 and

5 WHEREAS, in their short lives, Anthony and C.J. 6 epitomized what was right about our youth of today and their 7 memory will be cherished in the hearts and minds of those who 8 were fortunate to know them during their lifetime; now 9 therefore,

10 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH 11 HOUSES THEREOF CONCURRING, That in remembrance of Anthony Robinson, Jr., and Christopher "C.J." Boykins, we hereby 12 13 designate the portion of United States Highway 43 in Marengo 14 County from the city limits of Linden, Alabama, to the 15 intersection of Marengo County Road 47 as the "Anthony 16 Robinson, Jr., and Christopher "C.J." Boykins, Jr., Memorial 17 Highway."

18 BE IT FURTHER RESOLVED, That in keeping with 19 provisions of Sections 23-1-8 and 23-1-8.1 of the Code of 20 Alabama 1975, the Alabama Department of Transportation is 21 hereby requested to erect appropriate signage, to be paid for 22 fully with private funds provided by the Robinson and Boykins 23 Families or their friends, as specified in Section 23-1-8.1. The signage should be erected along the designated route. The 24 25 signage should incorporate the Great Seal of the State of

If possible, such signage should also incorporate the 1 official emblem of the Linden High School, University of West 2 3 Alabama, and the Demopolis Middle School provided all rights to incorporate such aforementioned emblems are granted by the 4 5 schools and the university. BE IT FURTHER RESOLVED, That if possible, the 6 signage should be designed and laid out in emblems and words 7 8 as follows: Great Seal of the State of Alabama 9 Anthony Robinson, Jr., and Christopher "C.J" 10 Boykins, Jr., Memorial Highway 11 12 Linden High School, University of West Alabama, and 13 the Demopolis Middle School emblems BE IT FURTHER RESOLVED, That such memorial 14 15 designation shall in no way alter or conflict with the 16 commonly designated United States Highway 43 and shall not 17 affect in any way postal or address designations along the 18 designated memorial route. 19 BE IT FURTHER RESOLVED, That a copy of this 20 resolution be presented to the immediate families of Anthony 21 Robinson, Jr., and Christopher "C.J" Boykins, Jr., so that 22 they may know of the esteem in which we hold their family 23 members.
