2 she was accepted into the graduate program at The University
3 of Alabama and earned a Doctor of Education degree; she is
4 also a proud member of Kappa Delta Pi International Honor
5 Society in Education; and

6 WHEREAS, Dr. Meyer is a pillar in her church and the
7 entire local community; she has been a member of Montgomery's
8 First Christian Church (Disciples of Christ) for more than 50
9 years and has served as Trustee, Elder, and Moderator of the
10 Board; she is also an avid supporter of children and youth
11 programs in her community; Dr. Meyer helped to establish a
12 special scholarship fund to assist students with their higher
13 education goals; and

14 WHEREAS, Dr. Meyer was presented the National
15 Association of State Directors of Teacher Education and
16 Certification (NASDTEC) Distinguished Leadership Award for her
17 K-12 teacher preparation and certification efforts; and

18 WHEREAS, NASDTEC officially named this prestigious
19 award in her honor; it is now the Jayne Meyer NASDTEC
20 Distinguished Leadership Award; and

21 WHEREAS, through the years, she has earned immense
22 respect for her tireless dedication and exceptional abilities,
23 and she is truly deserving of special recognition; now
