RECOGNIZING THE 22ND ANNUAL DELTA DAY AT THE ALABAMA  
STATE CAPITOL ON TUESDAY, FEBRUARY 18, 2014, AND COMMENDING  
DELTA SIGMA THETA SORORITY, INCORPORATED.

WHEREAS, it is with great pleasure that we recognize  
Delta Sigma Theta Sorority, Incorporated, on the observance of  
the 22nd Annual Delta Day on Tuesday, February 18, 2014, at  
the Alabama State Capitol; and

WHEREAS, a sisterhood founded on January 13, 1913,  
by 22 collegiate women at Howard University, Delta Sigma Theta  
Sorority now has grown to a membership of more than 250,000  
women, predominantly Black and college-educated, in more than  
1,000 chapters throughout the United States and abroad; and

WHEREAS, Delta Sigma Theta Sorority follows a  
national Five Point Program: Economic Development, Educational  
Development, International Awareness and Involvement, Physical  
and Mental Health, and Political Awareness and Involvement;  
the sorority promotes academic excellence, provides
