ENROLLED, House Joint Resolution,  
RECOGNIZING APPRECIATION DAY AT ENTERPRISE HIGH  
SCHOOL AND ENTERPRISE STATE COMMUNITY COLLEGE.

WHEREAS, it is a pleasure and privilege to recognize  
the observance of Appreciation Day for Enterprise High School  
and Enterprise State Community College on April 28, 2010; and

WHEREAS, Appreciation Day celebrates the  
collaboration that began in March 2007 after a devastating  
tornado destroyed Enterprise High School and the high school  
students began attending classes at Enterprise Ozark Community  
College; and

WHEREAS, Dr. Stafford L. Thompson, President of the  
College, and Dr. Jim Reese, Superintendent of Enterprise City  
Schools, established the cooperative venture that brought the  
administration, faculty, staff, and students of Enterprise  
High School to the Enterprise Campus of Enterprise State  
Community College; and

WHEREAS, the entire high school experience for the  
Enterprise High School Class of 2010 has been based at  
Enterprise State Community College; and

WHEREAS, each year, Enterprise State Community  
College has invited and welcomed Enterprise High School

1 students to such events as the Fall and Spring Bash and  
2 Founders Day; and

3 WHEREAS, Enterprise High School has approximately  
4 1,300 students and 200 faculty and staff annually and  
5 Enterprise Ozark Community College/Enterprise State Community  
6 College has approximately 1,200 students and 100 full-time  
7 faculty and staff annually; and

8 WHEREAS, each institution has gained immeasurably  
9 from this cooperative venture; and

10 WHEREAS, with Enterprise High School now prepared to  
11 move to its new campus, the 2010 observance of Appreciation  
12 Day takes on a special significance; now therefore,

13 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH  
14 HOUSES THEREOF CONCURRING, That in recognition of Appreciation  
15 Day on April 28, 2010, we honor and commend Enterprise High  
16 School and Enterprise State Community College, and by copy of  
17 this resolution for appropriate presentation and display, we  
18 celebrate the ongoing spirit of cooperation between these two  
19 outstanding educational institutions.
