constitute a violation of the constitutional right to privacy of countless Americans; this warrantless breach of private, personal information is without any clearly articulated purpose that could reasonably justify such a sweeping mandate; and

6 WHEREAS, furthermore, the Office of the President, 7 the Treasury, and the IRS have not issued satisfactory 8 assurances or explanations as to how the data would be stored, 9 protected, and used; and

10 WHEREAS, the right to privacy is a cornerstone of 11 American democracy; without a guarantee of privacy, the 12 erosion of other rights and freedoms is almost certain; and

WHEREAS, although this proposed plan is only the tip of the iceberg of the Biden Administration agenda, it is incumbent upon this body to rise in fervent defense of the financial privacy of the residents of this state and the entire nation; now therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE LEGISLATURE OF ALABAMA, That this body fervently opposes those provisions of the Biden Administration's American Families Plan containing the onerous tax information reporting proposal, and declares that proposal to be a sweeping invasion of financial privacy rights committed without reasonable justification.
