13 Our Lady of Good Counsel Homeschool; in his leisure time, he
14 enjoys playing guitar, collecting vinyl records, playing video
15 games, and reading; and

16 WHEREAS, Joshua Stephen Karg is an exceptional young
17 Alabamian who has indeed exemplified Scouting's admirable
18 attributes of self-discipline, self-reliance, good
19 citizenship, devotion to duty, and concern for his fellowman;

21 and his community, and he is truly deserving of this
