12 WHEREAS, it is with highest commendation that we 13 recognize the late Sheffield Police Sergeant James Nicholas 14 "Nick" Risner as a nominee for the 2022 Alabama Legislative 15 Law Enforcement Medal of Honor, Alabama's highest law 16 enforcement award for extraordinary courage in the line of 17 duty; and

1 WHEREAS, the life of Sergeant Risner was marked by 2 dedicated service to his country, community, and fellow man; a native of Florence, Alabama, he was born to Carl and Vicki 3 Risner and was endowed with a deep sense of civic 4 5 responsibility, which initially manifested as he served with 6 honor in the United States Army Reserve for eight years prior 7 to becoming a police officer; he was married to Brandy, his wife of 15 years, and they have one daughter, Aili, who was 8 9 the light of his life; he was a people person with a servant's 10 heart, always helping others in any way; his infectious laugh and personality could light up a room; he was the true 11 definition of a hero and continues to serve through his organ 12 13 donation; and

14 WHEREAS, there is no greater accomplishment than to 15 seek to successfully rescue a fellow citizen whose life is 16 imperiled; Sergeant Risner was a worthy exemplar of those 17 caring and dedicated men and women who stand ever ready to 18 provide prompt and professional response in times of crisis, 19 and he is highly deserving of this distinguished nomination 20 for the Legislative Medal of Honor; now therefore,
