12 National Distinguished Principal for Alabama by the National
13 Association of Elementary School Principals and the Alabama
14 Association of Elementary School Administrators; and

15 WHEREAS, Mr. Charles A. Gardner earned a bachelor of
16 science degree from Auburn University in 1990, a Master's
17 degree in 1992 from the University of Alabama, and educational
18 specialist degree from the University of Alabama in 1998; and

19 WHEREAS, Mr. Charles A. Gardner has served as an
20 educator in Alabama for 26 years; 19 as a principal; and

21 WHEREAS, Mr. Charles A. Gardner as principal of
22 Hokes Bluff Elementary School, leads professional learning for
23 faculty and staff prior to the beginning of each school year
24 to provide a venue of reiteration regarding the concept that
25 parents and community are valued stakeholders in the academic
26 support of the children in the school; and

2 Hokes Bluff Elementary School, holds monthly data meetings to
3 determine next steps for all students and make informed
4 decisions and measure progress for students, adults, and
5 overall school performance; and
