5	WINNING HIS FIFTH PRO TOUR.

7	WHEREAS, highest commendations and congratulations
8	are herein proudly conveyed to Alabama's own Dustin Connell
9	for scoring his fifth Bass Pro Tour Win at Stage One on
10	Toledo Bend, which was held in Many, Louisiana, from January
11	30, 2024 - February 4, 2024; and
12	WHEREAS, a native of Clanton, Alabama, Dustin Connell
13	developed a love and drive for fishing at a very young age;
14	he learned from his older brother, James, and followed him
15	to ponds and lakes to fish every chance he could; for hours
16	at a time, he would fish for bass at Lay Lake; and
17	WHEREAS, after fishing for fun for many years, he
18	competed in his first bass tournament with his brother when
19	he was only 12 years old; they ended up in second place and
20	he won \$100; he later said, "The thrill of the hunt, the
21	competition, the paycheck - every part of that first event
22	got me hooked on tournament fishing"; and
23	WHEREAS, a Chilton County High School Class of 2008
24	graduate, Dustin Connell matriculated to The University of
25	Alabama and earned a Bachelor of Science in Marketing, a
26	degree program he chose to help him work with sponsors as a
27	pro angler, which was always his motivating goal; he

29	and college angler; but he had to work long, hard hours in
30	construction after college in order to be in a position to
31	pursue tournament fishing full-time; and
32	WHEREAS, his determination and efforts paid off, and
33	in 2017 he claimed an Elite Series win and was named
34	B.A.S.S. Rookie of the Year; in 2018, he earned an
35	invitation to join Major League Fishing (MLF) on the Bass
36	Pro Tour; and
37	WHEREAS, winning Stage Three of the 2022 Bass Pro
38	Tour pushed him to nearly \$1 million in career earnings, and
39	he followed it up with a win at Stage Six of the 2022 Bass
40	Pro Tour; this win made Dustin Connell one of the winningest
41	anglers in Bass Pro Tour history as only Jacob Wheeler and
42	Ott DeFoe had won three or more events on the Bass Pro Tour;
43	he capped off the 2022 season with his fourth Bass Pro Tour
44	win at Stage Seven at Mille Lacs Lake; and
45	WHEREAS, in 2024, Dustin Connell scored his fifth
46	Bass Pro Tour win at Stage One on Toledo Bend; he claimed
47	victory by catching 36 bass that altogether weighed 112
48	pounds and 4 ounces; this remarkable achievement earned him
49	the first-place prize of \$100,000 at the MLF Bass Pro Tour
50	B&W Trailer Hitches Stage One at Toledo Bend, sponsored by
51	Power-Pole; his Championship Round total nearly doubled the
52	rest of the 10-man field, earning the win by a whopping
53	44-pound, 2-ounce margin over the second place winner;
54	Connell's total marked the biggest day for any angler during
55	the event; and
56	WHEREAS, in addition to this win marking his fifth

57	Bass Pro Tour victory, the second most of all-time, it was
58	his third straight in regular season events contested with
59	every-fish-counts scoring; and
60	WHEREAS, the occasion of Dustin Connell winning his
61	fifth Bass Pro Tour is an accomplishment to be celebrated;
62	his dedication, strong desire for success, constant
63	training, and tireless and diligent efforts to achieve
64	excellence serve as a valuable example to aspiring athletes
65	across the country and in his home State of Alabama; now
