7 serves in several capacities across the Ninth Episcopal
8 District in the State of Alabama; before serving in ministry
9 full-time, she pursued a corporate career for almost 24 years

12 areas of expertise include ministry collaborations, grant
13 writing, sales opportunity assessments, product presentations,
14 and revenue forecasting and tracking; and

17 Dean of Ministry Study, Conference Trustee, Christian
