3 he was promoted to County Director where he served for the
4 past 22 years; and

5 WHEREAS, Mr. Redmill was elected President of the
6 Alabama Association of County Directors of Human Resources,
7 and subsequently attended the Harvard University, John F.
8 Kennedy School of Government, Executive Development training
9 program; and

10 WHEREAS, Mr. Redmill represented the department
11 honorably and effectively serving on numerous boards
12 including: DA's Child Advocacy Center, Service Supervisors
13 Association, Project People-Walker County, American Red Cross,
14 Retired Senior Volunteer Program, Alabama Council on Child
15 Abuse, Jasper Kiwanis Club, Jasper Community Development
16 Corporation, Jasper Area Family Service Center, and Alabama
17 Association of County Directors of Human Resources; and

18 WHEREAS, Mr. Redmill's distinguished service earned
19 him the privilege of holding positions and working with the
20 following: Project People-Walker County, Alabama Department of
21 Human Resources Quality Assurance Workgroup, Alabama
22 Information Systems Collaborative Project, Alabama Council on
