11 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF 12 THE LEGISLATURE OF ALABAMA, That the Task Force on the Impact 13 of Dementia on Alabamians is created. The committee shall be 14 composed as follows: the Chair of the House of Representatives 15 Health Committee, the Commissioner of the Department of Mental Health, or a designee, the Director of the Department of 16 17 Public Health, or a designee, the Director of the Department of Senior Services, or a designee, the Commissioner of the 18 Alabama Medicaid Agency or a designee, the Commissioner of the 19 20 Department of Human Resources or a designee, two 21 representatives of the medical profession appointed by the Alabama Medical Association, two representatives of the 22 23 National African American Medical Association, two 24 representatives of the State Board of Health appointed by the 25 State Board of Health, and the following members to be 26 appointed by the Governor: One person with Alzheimer's 27 disease, one caregiver of a person with Alzheimer's disease, a

1 representative of the nursing facility industry, a 2 representative of the assisted living industry, a representative of the adult day services industry, a 3 4 representative of the probate judges association, a representative of the medical care provider industry, an 5 Alzheimer's disease researcher, at least four representatives 6 7 of community-based Alzheimer family support organizations, and a representative of AARP. The membership of the committee 8 shall be inclusive and reflect the racial, gender, geographic, 9 10 urban and rural, and economic diversity of the state. The Task 11 Force shall report to the Legislature no later than the 2nd 12 legislative day of the 2011 Regular Session the extent to 13 which the Task Force has complied with the diversity 14 provisions provided for in this resolution. The chair and vice 15 chair of the committee shall be elected at the first meeting by the members of the committee. The committee shall study all 16 17 facets of the impact of dementia such as Alzheimer's Disease on residents of Alabama. 18

Upon the request of the chair, the Secretary of the 19 Senate and the Clerk of the House of Representatives shall 20 21 provide necessary clerical assistance for the work of the 22 committee. The committee shall report its findings, 23 conclusions, and recommendations to the Legislature not later 24 than the 5th legislative day of the 2011 Regular Session, 25 whereupon the committee shall stand dissolved and discharged of any further duties and liabilities. Members shall serve 26

without compensation. The total expenditures of the committee shall not exceed \$5,000.
