9		and use taxes upon certain persons, firms, or
10		corporations. The amount of the taxes ranges from
11		one and one-half to four percent of the gross
12		proceeds of the sale or consumption of various

14		imposes a sales tax on the operation of places of

6	Larger Parish Incorporated is exempted from paying or
7	collecting any state, county, and municipal sales and use
8	taxes.
9	Section 2. This act shall become effective on the
10	first day of the third month following its passage and
11	approval by the Governor, or its otherwise becoming law.
