13	To amend Section 45-28-220.03, Code of Alabama 1975,
14	relating to the Etowah County Mega Sports Complex Authority;
15	to provide further for the membership of the authority; the
16	distribution of certain funds to the authority; the treatment
17	of debt; and routine audits.
18	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
19	Section 1. Section 45-28-220.03 of the Code of
20	Alabama 1975, is amended to read as follows:
21	"§45-28-220.03.
22	"(a) This section shall only apply in Etowah County.
23	"(b) The Etowah County Mega Sports Complex Authority
24	is created.
25	"(c)(1) The Immediately after the effective date of
26	the act adding this amendatory language, the terms of the

1	members serving on the authority shall end. Thereafter, the
2	authority shall consist of the following members:
3	"a. The legislative sponsor of the act creating the
4	authority.
5	"a. Except as otherwise provided in subparagraph 1.,
6	one b. A member appointed by each member of the local
7	legislative delegation. with initial terms expiring as
8	<pre>follows:</pre>
9	"1. House District 29, expiring November 10, 2022.
10	The initial appointment occurring after the effective date of
11	the act adding this amendatory language shall be made by the
12	Director of the Etowah County Tourism Board. Subsequent
13	appointments to this position shall be made by the legislative
14	member representing House District 29.
15	"2. House District 28, expiring November 10, 2023.
16	"3. House District 30, expiring November 10, 2024.
17	"4. Senate District 10, expiring November 10, 2025.
18	"b.c. The Director President of the Etowah County
19	Chamber of Commerce, or his or her designee.
20	"d. Three members appointed by the Director of the
21	Etowah County Chamber of Commerce.
22	"c. The Director of the Etowah County Tourism Board,
23	or his or her designee.
24	"d. One member appointed by the governing body of
25	the City of Rainbow City, for an initial term expiring
26	November 10, 2024.

1	"(2) <del>The authority may appoint additional members to</del>
2	the authority upon a majority vote of its members. Upon
3	completion of the initial staggered terms, subsequent
4	appointments of non ex-officio members shall be made in the
5	same manner for terms of four years.

- "(3) A member shall be removed from the authority after failing to attend three consecutive properly noticed regular meetings of the authority, or more than half of the properly noticed regular meetings, during a calendar year. The members of the authority shall meet at least quarterly and minutes of the meetings of the authority shall be posted on a website operated by the authority or on a social media website of the authority, or both, within 30 days after the meeting date. A vacancy on the authority for any reason shall be filled by appointment by the original appointing authority for the unexpired term.
- "(d) The authority shall evaluate the development of a sports complex for Etowah County for implementation and administration by the authority. The evaluation shall include, but is not limited to, the following considerations and issues:
- "(1) The feasibility of a mega sports complex for the county.
  - "(2) What should be included in such a complex.
  - "(3) The location of such a complex.
  - "(4) The cost associated with acquiring and maintaining such a complex.

- 1 "(5) Possible funding sources for such a complex.
- 2 "(e) After its evaluation, the authority may
- 3 initiate the development and management of a public mega
- 4 sports complex in the county.

- 5 "(f) The authority shall also have the following 6 powers and duties:
- 7 "(1) To acquire or lease real property for the 8 development of sports or other recreational facilities and 9 related improvements for public purposes.
  - "(2) To make, enter into, and execute contracts, agreements, or other instruments necessary to accomplish the purposes of this section.
  - "(3) To establish and appoint committees and hire staff which it deems necessary for the carrying out of its functions.
  - "(4) To accept any and all donations and grants of money, equipment, supplies, materials, and services, and to receive, utilize, and dispose of it.
    - "(5) To perform other functions as may be necessary or appropriate to achieve the purposes of this section.
  - "(g) All T.V.A. in-lieu-of-taxes payments to Etowah County retained by the county and not transferred to the City of Sardis pursuant to Section 40-28-2 shall be distributed to the Etowah County Mega Sports Complex Authority, to be used for the financing and operation of a mega sports complex.

1	"(h)(1) Any additional funds received by the
2	authority, from any state or county tax revenue, shall be
3	applied first toward the payment of existing debts.
4	"(2) Immediately upon the full payment of all debts
5	in existence as of October 1, 2021, all revenues referenced in
6	subsection (g) and subdivision (1) of Section 45-28-91.02,
7	shall be held in the county treasury until otherwise directed
8	by unanimous consent of the members of the legislative
9	delegation.
10	"(i) A comprehensive financial audit of the
11	authority shall be performed immediately after the effective
12	date of the act adding this subsection, annually for the
13	immediately succeeding two years, and every two years
14	thereafter. The audit shall be performed by a
15	licensed independent certified public accountant chosen by the
16	authority from a list of three auditing firms nominated by the
17	governing body of the City of Rainbow City. A copy of each
18	audit performed shall be submitted to the Chief Examiner of
19	the Department of Examiners of Public Accounts and each
20	appointing authority within 30 days after completion."
21	Section 2. This act shall become effective
22	immediately following its passage and approval by the
23	Governor, or its otherwise becoming law.
