The members of the authority shall constitute all the members of the board of 6 directors of the authority, and any two members of the said 7 8 board of directors shall constitute a quorum for the 9 transaction of business. Should any person holding any state 10 office named in this section cease to hold such office by reason of death, resignation, expiration of his term of office 11 or for any other reason, then his successor in office shall 12 take his place as an officer and member of the board of 13 14 directors of the authority. No officer or member of the board of directors of the authority shall draw any salary in 15 16 addition to that now authorized by law for any service he may render or for any duty he may perform in connection with the 17 authority. 18

"(b) All proceedings had and done by the board of directors shall be reduced to writing by the secretary of the authority, shall be signed by at least two members of the authority present at the proceedings and shall be recorded in a substantially bound book and filed in the office of the Secretary of State. Copies of such proceedings, when certified by the secretary of the authority under the seal of the
