Also, under 13 existing constitutional provisions, the Lieutenant 14 Governor and the Governor are elected separately. 15 This bill would propose an amendment to the Constitution of Alabama of 1901, which would 16 17 require the Governor and Lieutenant Governor to be 18 elected jointly, would remove the power of the 19 Lieutenant Governor to preside over the Senate and 20 to vote in the event of a tie, and would provide 21 that the sole duty of the Lieutenant Governor would 22 be to succeed to the office of the Governor upon 23 the Governor's removal from office, death, or 24 resignation. 25 This bill would also specify that the Lieutenant Governor would hold no duties,

Legislative Department. This bill would require the members of the Senate to elect from its membership a President of the Senate and would provide that the prior legislative duties, responsibilities, and powers of the Lieutenant Governor would be vested in the President of the Senate. The bill would also provide that the President Pro Tempore of the Senate would preside over the Senate in the absence of the President of the Senate.

This bill would specify that the annual salary of the Lieutenant Governor would be an amount equal to 75 percent of the annual salary paid to the Governor.

Proposing an amendment to Section 117 of the

Constitution of Alabama of 1901; requiring the Governor and

Lieutenant Governor to be elected jointly; removing the duty

of the Lieutenant Governor to serve as the President of the

Senate and other duties, responsibilities, and powers

regarding the Legislative Department; specifying that the sole

duty of the Lieutenant Governor is to succeed to the Office of

Governor under certain existing conditions; vesting these

duties, responsibilities, and powers with the President of the

Senate who shall be elected by the members of the Senate from the membership of the Senate; providing that the President Pro Tempore of the Senate would preside over the Senate in the absence of the President of the Senate; and providing for the annual salary of the Lieutenant Governor.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to Section 117 of the Constitution of Alabama of 1901, as amended, is proposed and shall become valid as a part thereof when approved by a majority of the qualified electors voting thereon and in accordance with Sections 284, 285, and 287 of the Constitution of Alabama of 1901, as amended:

PROPOSED AMENDMENT

"Section 117.

"(a) The governor and lieutenant governor shall each be at least thirty years of age when elected, and shall have been citizens of the United States ten years and resident citizens of this state at least seven years next before the date of their election. The lieutenant governor shall be ex officio president of the senate, but shall have no right to vote except in the event of a tie.

"(b) Commencing with the first general election for Governor and Lieutenant Governor following ratification of this amendment, and in every election for Governor and Lieutenant Governor held thereafter, one vote shall be cast jointly for the candidates for Governor and Lieutenant Governor nominated by the same political party or petition.

Т	The Legislature shall provide by general law for the
2	nomination of candidates for Governor and Lieutenant Governor.
3	"(c) The sole duty of the Lieutenant Governor is to
4	succeed to the Office of the Governor as specified in Section
5	127. The Lieutenant Governor shall not serve as President of
6	the Senate and shall hold no right to vote in the event of a
7	tie. The Lieutenant Governor shall hold no duties,
8	responsibilities, or powers regarding the Legislative
9	Department.
10	"(d) The members of the Senate, from time to time,
11	shall elect from its membership a President of the Senate.
12	Those legislative duties, responsibilities, and powers
13	previously vested in the Lieutenant Governor by this

25	Section 2. An election upon the proposed amendment
26	shall be held in accordance with Sections 284 and 285 of the
27	Constitution of Alabama of 1901, now appearing as Sections 284

and 285 of the Official Recompilation of the Constitution of
Alabama of 1901, as amended, and the election laws of this
state.

Section 3. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the following description of the substance or subject matter of the proposed constitutional amendment:

"Proposing an amendment to the Constitution of Alabama of 1901, providing the Governor and Lieutenant Governor would be elected jointly; removing the duty of the Lieutenant Governor to serve as the President of the Senate and to perform other legislative responsibilities; vesting these legislative duties in the President of the Senate, who shall be elected by the members of the Senate; specifying the sole duty of the Lieutenant Governor is to succeed to the Office of Governor under certain existing conditions; and providing that the annual salary of the Lieutenant Governor is an amount equal to 75 percent of the annual salary of the Governor.
