8 TO BE ENTITLED  
9 AN ACT

11 To make a supplemental appropriation from the  
12 Education Trust Fund to the State Department of Education in  
13 the amount of \$3,112,615 for the fiscal year ending September  
14 30, 2019; to make a supplemental appropriation from the  
15 Education Trust Fund to the Department of Rehabilitation  
16 Services in the amount of \$1,550,000 for the fiscal year  
17 ending September 30, 2019; to make a supplemental  
18 appropriation from the Education Trust Fund to the Alabama  
19 Public Library Service in the amount of \$500,000 for the  
20 fiscal year ending September 30, 2019; to make a supplemental  
21 appropriation from the Education Trust Fund to the Alabama  
22 Building Renovation Finance Authority in an amount up to  
23 \$650,000 for the fiscal year ending September 30, 2019; to  
24 make a supplemental appropriation from the Education Trust  
25 Fund to the Lieutenant Governor Workforce Commission in the  
26 amount of \$150,000 for the fiscal year ending September 30,  
27 2019; to make a supplemental appropriation from the Education

1 Trust Fund to the Alabama Community College System for the  
2 Dual Enrollment Program in the amount of \$977,997 for the  
3 fiscal year ending September 30, 2019; and to make a  
4 supplemental appropriation from the Alabama Board of Nursing  
5 Trust Fund to the Alabama Board of Nursing in the amount of  
6 \$570,000 for the fiscal year ending September 30, 2019.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. In addition to all other appropriations  
9 heretofore or hereafter made, there is hereby appropriated  
10 \$3,112,615 from the Education Trust Fund to the State  
11 Department of Education for the fiscal year ending September  
12 30, 2019. Of this appropriation, \$1,809,535 shall be expended  
13 for start-up costs incurred in connection with the  
14 implementation of a new Student Administration System;  
15 \$303,080 shall be expended for pilot projects to address  
16 dyslexia; and \$1,000,000 shall be expended to support the  
17 development of programs specifically targeted at literacy,  
18 numeracy, and career and technical education through the  
19 expansion of professional development opportunities for  
20 teachers in the summer of 2019.

21 Section 2. In addition to all other appropriations  
22 heretofore or hereafter made, there is hereby appropriated  
23 \$1,550,000 from the Education Trust Fund to the Department of  
24 Rehabilitation Services for the fiscal year ending September  
25 30, 2019. Of this appropriation, \$1,300,000 shall be expended  
26 for the Early Intervention Program and \$250,000 shall be

1 transferred to the Alabama Head and Spinal Cord Injury Trust  
2 Fund.

3 Section 3. In addition to all other appropriations  
4 heretofore or hereafter made, there is hereby appropriated  
5 \$500,000 from the Education Trust Fund to the Alabama Public  
6 Library Service for the fiscal year ending September 30, 2019.  
7 Of this appropriation, \$250,000 shall be distributed to the  
8 Alabama Supreme Court Library and \$250,000 is to be  
9 distributed to public libraries within the State.

10 Section 4. In addition to all other appropriations  
11 heretofore or hereafter made, there is hereby appropriated up  
12 to \$650,000 from the Education Trust Fund to the Alabama  
13 Building Renovation Finance Authority for the fiscal year  
14 ending September 30, 2019. This appropriation shall be  
15 expended to reimburse the Authority for expenditures incurred  
16 related to bicentennial activities. This appropriation shall  
17 be limited to the amount necessary to reimburse the Authority.

18 Section 5. In addition to all other appropriations  
19 heretofore or hereafter made, there is hereby appropriated  
20 \$150,000 from the Education Trust Fund to the Lieutenant  
21 Governor Workforce Commission for the fiscal year ending  
22 September 30, 2019.

23 Section 6. In addition to all other appropriations  
24 heretofore or hereafter made, there is hereby appropriated  
25 \$977,997 from the Education Trust Fund to the Alabama  
26 Community College System for the Dual Enrollment Program for  
27 the fiscal year ending September 30, 2019.

1                   Section 7. In addition to all other appropriations  
2 heretofore or hereafter made, there is hereby appropriated  
3 \$570,000 from the Alabama Board of Nursing Trust Fund to the  
4 Alabama Board of Nursing for necessary internal server  
5 upgrades for the fiscal year ending September 30, 2019.

6                   Section 8. This act shall become effective  
7 immediately upon its passage and approval by the Governor, or  
8 upon its otherwise becoming law.
