4 ENROLLED, An Act,

5 To make a supplemental appropriation from the
6 Education Trust Fund to the State Department of Education in
7 the amount of \$3,112,615 for the fiscal year ending September
8 30, 2019; to make a supplemental appropriation from the
9 Education Trust Fund to the Department of Rehabilitation
10 Services in the amount of \$1,550,000 for the fiscal year
11 ending September 30, 2019; to make a supplemental
12 appropriation from the Education Trust Fund to the Alabama
13 Public Library Service in the amount of \$500,000 for the
14 fiscal year ending September 30, 2019; to make a supplemental
15 appropriation from the Education Trust Fund to the Alabama
16 Building Renovation Finance Authority in an amount up to
17 \$650,000 for the fiscal year ending September 30, 2019; to
18 make a supplemental appropriation from the Education Trust
19 Fund to the Lieutenant Governor Workforce Commission in the
20 amount of \$150,000 for the fiscal year ending September 30,
21 2019; to make a supplemental appropriation from the Education
22 Trust Fund to the Alabama Community College System for the
23 Dual Enrollment Program in the amount of \$977,997 for the
24 fiscal year ending September 30, 2019; and to make a
25 supplemental appropriation from the Alabama Board of Nursing

1 Trust Fund to the Alabama Board of Nursing in the amount of
2 \$570,000 for the fiscal year ending September 30, 2019.

3 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

4 Section 1. In addition to all other appropriations
5 heretofore or hereafter made, there is hereby appropriated
6 \$3,112,615 from the Education Trust Fund to the State
7 Department of Education for the fiscal year ending September
8 30, 2019. Of this appropriation, \$1,809,535 shall be expended
9 for start-up costs incurred in connection with the
10 implementation of a new Student Administration System;
11 \$303,080 shall be expended for pilot projects to address
12 dyslexia; and \$1,000,000 shall be expended to support the
13 development of programs specifically targeted at literacy,
14 numeracy, and career and technical education through the
15 expansion of professional development opportunities for
16 teachers in the summer of 2019.

17 Section 2. In addition to all other appropriations
18 heretofore or hereafter made, there is hereby appropriated
19 \$1,550,000 from the Education Trust Fund to the Department of
20 Rehabilitation Services for the fiscal year ending September
21 30, 2019. Of this appropriation, \$1,300,000 shall be expended
22 for the Early Intervention Program and \$250,000 shall be
23 transferred to the Alabama Head and Spinal Cord Injury Trust
24 Fund.

1 Section 3. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$500,000 from the Education Trust Fund to the Alabama Public
4 Library Service for the fiscal year ending September 30, 2019.
5 Of this appropriation, \$250,000 shall be distributed to the
6 Alabama Supreme Court Library and \$250,000 is to be
7 distributed to public libraries within the State.

8 Section 4. In addition to all other appropriations
9 heretofore or hereafter made, there is hereby appropriated up
10 to \$650,000 from the Education Trust Fund to the Alabama
11 Building Renovation Finance Authority for the fiscal year
12 ending September 30, 2019. This appropriation shall be
13 expended to reimburse the Authority for expenditures incurred
14 related to bicentennial activities. This appropriation shall
15 be limited to the amount necessary to reimburse the Authority.

16 Section 5. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$150,000 from the Education Trust Fund to the Lieutenant
19 Governor Workforce Commission for the fiscal year ending
20 September 30, 2019.

21 Section 6. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$977,997 from the Education Trust Fund to the Alabama
24 Community College System for the Dual Enrollment Program for
25 the fiscal year ending September 30, 2019.

1 Section 7. In addition to all other appropriations
2 heretofore or hereafter made, there is hereby appropriated
3 \$570,000 from the Alabama Board of Nursing Trust Fund to the
4 Alabama Board of Nursing for necessary internal server
5 upgrades for the fiscal year ending September 30, 2019.

6 Section 8. This act shall become effective
7 immediately upon its passage and approval by the Governor, or
8 upon its otherwise becoming law.
