2 and all real and personal property of all volunteer fire departments in this state, the Alabama Society of the 3 Daughters of the American Revolution, and all real and personal property of the Alabama Society of the Daughters of 5 the American Revolution, the Annual Shrine Circus as well as 6 7 all other charitable Shrine amusement and fund raising events, and all real and personal property of the Annual Shrine 8 Circus, the Episcopal Foundation of Jefferson County, and all 9 10 real and personal property of the Episcopal Foundation of Jefferson County, the Alabama Heart Association and all real 11 12 and personal property of the Alabama Heart Association, and 13 the Presbyterian Apartments, Incorporated, and all real and 14 personal property of the Presbyterian Apartments, 15 Incorporated, when such real and personal property shall be used as provided in Section 40-9-12, are exempt from the 16 17 payment of any and all state, county and municipal taxes, licenses, fees and charges of any nature whatsoever, including 18 any privilege or excise tax heretofore or hereafter levied by 19 20 the State of Alabama or any county or municipality thereof. 21
