SB262 1 2 3 4 ENROLLED, An Act, 5 To create the Alabama Interagency Council for the Prevention of Elder Abuse; to provide for the membership and 6 7 duties of the council; to allow the council to adopt rules for its internal operations; and to establish a lead agency for 8 9 the council. 10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA: 11 Section 1. This act shall be known and may be cited 12 as the Elder Abuse Prevention Act. Section 2. The following words are defined for the 13 14 purposes of this act: 15 (1) COORDINATED SYSTEM OF CARE. The total effort in the state, inclusive of service coordination/case management, 16 17 that is directed at meeting the needs of individuals who are 18 at risk of elder abuse. 19 (2) COUNCIL. The Alabama Interagency Council for the 20 Prevention of Elder Abuse. 21 (3) ELDER ABUSE. The maltreatment of an older 22 person, age 60 or above, by any person, including the 23 following: 24 a. Emotional/Psychological Abuse. The intentional 25 infliction of mental or emotional anguish by threat,

humiliation, intimidation, or other verbal or non-verbal abusive conduct. Examples of psychological abuse include name calling, insulting, ignoring for extended periods of time, frightening, intimidating, and isolating from friends and family.

6 b. Material Exploitation. The unauthorized use of 7 funds or any resources of an elderly individual; the misuse of 8 power of attorney or representative payee status for one's own 9 advantage or profit. Examples include stealing jewelry or 10 other property and obtaining the elderly person's signature 11 for transfer of property or for a will through duress or 12 coercion.

13 c. Neglect. The intentional or unintentional failure 14 by the caregiver to obtain adequate goods or services for the 15 elderly person's maintenance and well-being. Examples include 16 a caregiver who fails to buy groceries or prescription 17 medications.

d. Physical Abuse. The intentional use of physical
force that results in bodily injury, pain, or impairment.
Examples of physical abuse include beating, slapping,
bruising, cutting, burning, pushing or shoving, excessively
restraining, force-feeding, and physical punishment.

e. Self-neglect. Behavior of an elderly person thatthreatens his or her own health or safety. Examples are

failure to provide oneself with adequate food, clothing, 2 shelter, medication, safety, and proper hygiene.

f. Sexual Abuse. The non-consensual sexual contact 3 of any kind with an elderly individual. Examples include 4 5 fondling of the breast or genitals, rape, coerced nudity, and sexually explicit photographing. 6

7 (4) LEAD AGENCY. The Department of Senior Services shall be designated to be the lead agency for the council. 8

9 (5) PARTICIPATING AGENCY. A department, commission, 10 council, board, division, community service provider, or an 11 office or other entity which may provide services to 12 individuals at risk of elder abuse and their families.

(6) POLICIES. Directives by the lead agency, 13 14 participating agencies, the executive committee, or other written documents that represent the position of the council 15 concerning any matter within the purview of this act. 16

17 Section 3. There is created the Alabama Interagency Council for the Prevention of Elder Abuse. The members of the 18 19 council shall include, but not be limited to, the following:

20 (1) The chief executive officer, or his or her 21 designee, of each of the following participating agencies and 22 organizations:

23 a. The Alabama 911 Network.

b. The Administrative Office of Courts. 24

The Alabama Silver-Haired Legislature. 2 (2) The membership of the council shall be inclusive and reflect the racial, gender, geographic, urban/rural, and 3 economic diversity of the state. 4 5 (3) The chief executive officers of state agencies serving on the council shall serve ex officio. 6 7 (4) The council shall meet at least bi-monthly and the meetings shall be open to the public. 8 (5) No member of the council shall cast a vote on 9 any matter which would provide direct financial benefit to 10 that member or otherwise give the appearance of a conflict of 11 12 interest under state law. 13 (6) The Commissioner of the Department of Senior 14 Services shall serve as the chair of the council. Section 4. The council shall have the following 15 16 duties and authority: 17 (1) Define the roles and responsibilities of all 18 participating agencies. 19 (2) Adopt rules for the internal operation of the 20 council. 21 (3) Recommend to the Commissioner of the Department 22 of Senior Services appointment of additional members to serve on the council as deemed necessary and appropriate. 23 24 (4) Develop a long-range plan, reviewed 25 semi-annually, for a comprehensive statewide system of care,

which, to the extent practical, is derived from scientific based research and nationally recognized best practices. The council shall provide a copy of the plan and a detailed summary of any progress toward implementation of the plan to the Governor and the Legislature on or before the 10th legislative day of each regular session. The plan should include, but not be limited to, all of the following:

a. The elimination of barriers to identifying and
reporting elder abuse such as duplicative or fragmented
policies which may require modification.

b. The development of a coordinated program of services for victims of elder abuse to include the identification, intervention, prevention, and prosecution of the crime of elder abuse.

c. A comprehensive fiscal review and analysis with
 recommendations for state spending on programs and services
 for elder abuse prevention.

18 d. The identification of annual action steps toward19 implementation.

(5) Ensure interagency collaboration, public
participation, and mutual sharing of information to facilitate
policy decisions and the implementation of a plan for a
comprehensive statewide system of care to those at risk for
elder abuse.

Section 5. The Department of Senior Services shall 1 2 be responsible for the general administration, supervision, and monitoring of all council activities. 3 Section 6. The implementation of this act shall be 4 5 subject to the availability of appropriations to expand, 6 intensify, and coordinate the activities of the council. The 7 activities of the council shall include the expansion of council membership. 8 9 Section 7. The council shall be subject to the 10 Alabama Sunset Law, Chapter 20, Title 41, Code of Alabama 11 1975, as an enumerated agency as provided in Section 41-20-3, 12 Code of Alabama 1975, and shall have a termination date of 13 October 1, 2015, and every four years thereafter, unless 14 continued pursuant to the Alabama Sunset Law. 15 Section 8. This act shall become effective on the first day of the third month following its passage and 16

approval by the Governor, or its otherwise becoming law.
