(2) To gain the voluntary assistance of the 14 15 broadcast media to help locate missing senior citizens. "\$26-19A-4. 16 17 "(a) A missing senior citizen alert shall be 18 activated by the department when a senior citizen is reported 19 missing and an investigation reveals the following: 2.0 "(1) The <del>senior</del> citizen is at risk of bodily harm or 21 death, or suffers from Alzheimer's disease or dementia. An alert may be issued for a person suffering from Alzheimer's 22 23 disease or dementia regardless of age. 24 "(2) There is enough descriptive information about the senior or person suffering from Alzheimer's disease or 25 26 dementia to believe an immediate media alert would help

"(b) A report of a missing senior citizen or missing person suffering from Alzheimer's disease or dementia may be made to the department as soon as a concerned party or caregiver believes the person to be missing. Upon the submission of the report, a search in the missing person's local area may begin immediately, and the department may expand the search to include areas outside of the missing person's local area if needed.

"(c) The department and local law enforcement
agencies shall require law enforcement officers, 911
operators, and other emergency personnel to complete training
in techniques for searching for a missing person with
Alzheimer's disease or dementia. If a missing person report is
made for a person suffering from Alzheimer's disease or
dementia, the department and local law enforcement agencies
shall utilize available personnel who have participated in
this training to assist in conducting the search."

Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
