4 ENROLLED, An Act,

5 Relating to the Alabama Construction Recruitment  
6 Institute; to subject the institute to the Alabama Sunset Law;  
7 to amend Section 7 of Act 2009-561, 2009 Regular Session (Acts  
8 2009, p. 1629), as confirmed in Section 7 of Act 2010-220,  
9 2010 Regular Session (Acts 2010, p. 365), and to repeal  
10 Section 7 of Act 2010-220, 2010 Regular Session (Acts 2010, p.  
11 365), to provide for the continued collection of construction  
12 craft industry fees.

13 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

14 Section 1. The Alabama Construction Recruitment  
15 Institute shall be subject to the Alabama Sunset Law, Chapter  
16 20, Title 41, Code of Alabama 1975, as an enumerated agency as  
17 provided in Section 41-20-3, Code of Alabama 1975, and shall  
18 have a termination date of October 1, 2014, and every four  
19 years thereafter, unless continued pursuant to the Alabama  
20 Sunset Law.

21 Section 2. Section 7 of Act 2009-561, 2009 Regular  
22 Session (Acts 2009, p. 1629), as confirmed in Section 7 of Act  
23 2010-220, 2010 Regular Session (Acts 2010, p. 365), providing  
24 for the expiration of the collection of construction craft  
25 industry fees, is amended to read as follows:

1           "Section 7. This act shall become effective  
2 immediately following its passage and approval by the  
3 Governor, or its otherwise becoming law, and the passage and  
4 approval by the Governor of SB301 of the 2009 Regular Session  
5 of the Alabama Legislature, or SB301 otherwise becoming law."

6           Section 3. All laws or parts of laws which conflict  
7 with this act are repealed. Specifically, Section 7 of Act  
8 2010-220, 2010 Regular Session (Acts 2010, p. 365), confirming  
9 the expiration of the collection of construction craft  
10 industry fees on May 18, 2013, as provided in Section 7 of Act  
11 2009-561, 2009 Regular Session (Acts 2009, p. 1629), is  
12 repealed.

13           Section 4. This act shall become effective  
14 immediately following its passage and approval by the  
15 Governor, or its otherwise becoming law.
