22	following capabilities:
23	"a. Search and retrieval of all statements, reports,
24	and other filings required by this chapter, excluding
25	complaints made confidential by Section 36-25-4(b), by the

1 name of the public official or public employee to which they
2 pertain.

"b. Generation of an aggregate list of all things of value provided to each public official or public employee and family member of a public official or public employee as reported pursuant to Section 36-25-19, searchable and retrievable by the name of the public official or public employee.

9 "(b) Notwithstanding subsection (a), the commission 10 shall exclude from any electronic database accessible to the 11 public, identifying information, as defined in Section 12 41-13-7, that is included in any statement of economic 13 interest filed by any public official or public employee.

14 "(c) The commission shall redact all identifying 15 information on any electronic database accessible to the 16 public, as defined in Section 41-13-7, that is included in any 17 statement of economic interest filed by a public official or 18 public employee and was in the database on August 1, 2013."

Section 2. This act shall become effective
immediately following its passage and approval by the
Governor, or its otherwise becoming law.
