1 Relating to education; to amend Section 16-33C-4.1, 2 Code of Alabama 1975, relating to the composition and operation of the Prepaid Affordable College Tuition Program 3 board, to provide for the use of virtual technology to 4 5 participate in meetings; and to make nonsubstantive, technical 6 revisions to update the existing code language to current 7 style. BE IT ENACTED BY THE LEGISLATURE OF ALABAMA: Section 1. Section 16-33C-4.1, Code of Alabama 1975, 9 10 is amended to read as follows: "\$16-33C-4.1. 11 "(a) The PACT board shall consist of 15 members as 12 13 follows: 14 "(1) The Director of Finance. 15 "(2) The State Treasurer. 16 "(3) Two persons appointed by the Governor. 17 "(4) Two persons appointed by the Speaker of the 18 House of Representatives, one of whom shall be a PACT contract holder. 19 "(5) One person appointed by the Lieutenant 2.0 21 Governor. 2.2 "(6) One person appointed by the Senate President 23 Pro Tempore. 24 "(7) The President of the Council of College and 25 University Presidents or his or her designee. - 7 "(12) The Chief Executive Officer of the Retirement 8 Systems of Alabama or his or her designee.
 - "(13) The President of the Alabama Association of Independent Colleges and Universities or his or her designee.
 - "(b) Members shall serve for terms of office of four years and shall be eligible for reappointment, and shall serve until a successor is appointed. Any person appointed to fill a vacancy on the PACT board shall be appointed in a like manner and shall serve for only the unexpired term.
 - "(c) With the exception of those members serving on the PACT board by virtue of their respective offices, a person appointed to the PACT board shall be an expert in the field of investments, market analysis, or financial planning, or on similar matters commensurate with the duties and responsibilities of the plan. Additionally, all members of the PACT board have the fiduciary responsibility to devise and implement an investment strategy designed to maximize investment returns in a manner that correlates with future projected benefit payouts.
 - "(d) Members of the PACT board shall serve without compensation, but may be reimbursed for each day's official

duties of the PACT board at the same per diem and travel rate as is paid the employees of the state.

"(e) (1) The State Treasurer shall be the chair and presiding officer of the PACT board, and the State Treasurer may appoint such other officers as the PACT board may deem advisable or necessary. A majority of the members of the PACT board shall constitute a quorum for the transaction of the business of the plan.

"(2) Members of the PACT board or any committee established by the PACT board may participate in a meeting of the board or committee by means of telephone conference, video conference, or similar communications equipment by means of which all persons participating in the meeting may hear each other at the same time. Participation by means authorized in this subdivision shall constitute presence in person at a meeting for all purposes, including the establishment of a quorum, to deliberate and to take action. The telephone or video conference or similar communications equipment shall also allow members of the public the opportunity to simultaneously listen to or observe meetings held pursuant to this subdivision.

"(f) Except as otherwise specifically provided in subdivision (e)(2) only as it relates to virtual participation of members of the board and the public, all meetings and notice of meetings of the board shall be held in accordance with the Alabama Open Meetings Act, Section 36-25A-1 et seq.

1	" (f) The membership of the PACT board shall be
2	inclusive and reflect the racial, gender, geographic,
3	urban/rural, and economic diversity of the state. (g) All
4	appointing authorities shall coordinate their appointments so
5	that diversity of gender, race, and geographical areas is
6	reflective of the makeup of this state. The PACT board shall
7	annually report to the Legislature by the fifth legislative
8	day of each regular session the extent to which the PACT board
9	has complied with the diversity provisions provided for in
