SYNOPSIS:

This bill makes an appropriation of \$389,327 from the Education Trust Fund to Southern Preparatory Academy, formerly Lyman Ward Military Academy, in Camp Hill, Alabama for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2024; provides that the appropriation is subject to certain provisions of the Code of Alabama 1975; requires an operations plan and an audited financial statement prior to the release of any funds; and requires an end of year report.

AN ACT

To make an appropriation of \$389,327 from the Education Trust Fund to Southern Preparatory Academy, formerly Lyman Ward Military Academy, in Camp Hill, Alabama for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2024; to provide that the appropriation is subject to certain provisions of the Code of Alabama 1975; to require an operations plan and an audited financial statement prior to the release of any funds; and to

29 require an end of year report.

30 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

31 Section 1. There is hereby appropriated the sum of  
32 \$389,327 from the Education Trust Fund to Southern Preparatory  
33 Academy, formerly Lyman Ward Military Academy, in Camp Hill,  
34 Alabama for the support and maintenance of the educational  
35 program of the institution, for the fiscal year ending  
36 September 30, 2024.

37 Section 2. The above appropriation is made for the  
38 support of public education in Alabama and for the support and  
39 maintenance of the above program. The appropriation shall be  
40 subject to the provisions, terms, conditions, and limitations  
41 of the Budget and Financial Control Act, Code of Alabama 1975,  
42 Section 41-4-80 et seq.; the provisions of the Budget  
43 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1  
44 et seq.; and any other provisions of this act.

45 Section 3. (a) Prior to the release of any funds  
46 appropriated under this act, the following reports shall be  
47 submitted:

48 (1) An operations plan for the fiscal year 2024,  
49 including goals and measurable performance indicators, shall  
50 be submitted to and approved by the Director of Finance, as  
51 provided for state agencies in Code of Alabama 1975, Section  
52 41-19-10.

53 (2) An audited financial statement for all operations  
54 during the fiscal year 2022.

55 (b) It is the intent that funds appropriated for fiscal  
56 year 2024 shall be released by the Director of Finance

57 following receipt of the above reports.

58 (c) In addition, quarterly reports shall be made to the  
59 Director of Finance relating actual expenditures and  
60 accomplishments to planned expenditures and accomplishments.  
61 An end of year performance report for the fiscal year 2024  
62 shall be made to the Director of Finance stating the work  
63 accomplished and the services provided and the costs of  
64 accomplishing the work and providing the services, citing  
65 meaningful measures of program effectiveness and costs, as is  
66 required for state agencies in Code of Alabama 1975, Section  
67 41-19-11.

68 (d) The Director of Finance shall forward a copy of all  
69 required reports to the Legislative Council in a timely  
70 manner.

71 Section 4. This act shall become effective October 1,  
72 2023.
