Section 1. Section 34-30-57 of the Code of Alabama
1975, is amended to read as follows:

10 "In addition to the duties set forth elsewhere in 11 this chapter, the Board of Social Work Examiners shall <u>do all</u> 12 <u>of the following</u>:

"(1) Recommend modifications and amendments to thischapter.

15 "(2) Recommend to the appropriate district attorneys 16 prosecutions for the violations of this chapter, after and 17 only after the alleged violator has been notified of such 18 violation or violations and having been given 90 days to 19 disclaim, amend, and rectify such allegation.

20 "(3) Annually publish a list of the names and21 addresses of all persons who are:

"a. "Licensed bachelor social workers," "licensed
 graduate master social workers," and "licensed certified
 <u>independent clinical</u> social workers" under this chapter.

25 "b. Eligible to engage in the private independent26 practice of social work under this chapter.

"(4) Establish fees for initial examination,
licensure, certification, and renewal thereof; fees for
<u>verifying the existence of a current license, reactivating an</u>
<u>inactive license, and reinstating a lapsed license; fees for</u>
<u>making application to the board to act as a continuing</u>
<u>education provider; and fees for registering a supervisor</u>.

7 "(5) Establish requirements and standards for continuing education. In establishing such requirements, the 8 9 board shall consult with those groups and organizations which 10 represent both the levels of practice specified in this chapter and the various settings in which social work is 11 practiced. Furthermore, in developing such requirements, the 12 13 board shall consider, but shall not be limited in its consideration to, agency recognized staff development programs 14 15 under the auspices of public agencies, continuing education programs offered by colleges and universities having social 16 17 work programs approved or accredited by the Council on Social 18 Work Education, and continuing education programs offered by recognized state and national social work bodies. 19

20 "(6) Promulgate Adopt rules and regulations pursuant 21 to the State Alabama Administrative Procedures Statute 22 Procedure Act that set forth professional standards for "licensed bachelor social workers," "licensed graduate master 23 24 social workers, " and "licensed <del>certified</del> independent clinical 25 social workers" who are certified for the private independent practice of social work. Those proposed rules and regulations 26 shall be published at least 30 days prior to before the public 27

hearing relative to the proposed rules and regulations, and at least 15 days in advance of such before the hearing, the board shall publish notice of the date, time, and place where such <u>the</u> public hearings of the board will shall be held for the purpose of adopting or amending rules and regulations pertaining to this chapter."

Governor, or its otherwise becoming law.
