8 SYNOPSIS: This bill makes a supplemental appropriation
9 from the Home Builders Property Acquisition Fund to
10 the Home Builders Licensure Board in the amount of
11 \$600,000 for the fiscal year ending September 30,
12 2019; makes a supplemental appropriation from the
13 Alabama State Board of Midwifery Fund to the
14 Alabama State Board of Midwifery in the amount of
15 \$25,000 for the fiscal year ending September 30,
16 2019; and makes a supplemental appropriation from
17 the Alabama Behavior Analyst Licensing Board Fund
18 to the Alabama Behavior Analyst Licensing Board in
19 the amount of \$30,000 for the fiscal year ending
20 September 30, 2019.

26 To make a supplemental appropriation from the Home
27 Builders Property Acquisition Fund to the Home Builders

1 Licensure Board in the amount of \$600,000 for the fiscal year
2 ending September 30, 2019; to make a supplemental
3 appropriation from the Alabama State Board of Midwifery Fund
4 to the Alabama State Board of Midwifery in the amount of
5 \$25,000 for the fiscal year ending September 30, 2019; and to
6 make a supplemental appropriation from the Alabama Behavior
7 Analyst Licensing Board Fund to the Alabama Behavior Analyst
8 Licensing Board in the amount of \$30,000 for the fiscal year
9 ending September 30, 2019.

10 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

11 Section 1. In addition to all other appropriations
12 heretofore or hereafter made, there is hereby appropriated
13 \$600,000 from the Home Builders Property Acquisition Fund to
14 the Home Builders Licensure Board for the fiscal year ending
15 September 30, 2019.

16 Section 2. In addition to all other appropriations
17 heretofore or hereafter made, there is hereby appropriated
18 \$25,000 from the Alabama State Board of Midwifery Fund to the
19 Alabama State Board of Midwifery for the fiscal year ending
20 September 30, 2019.

21 Section 3. In addition to all other appropriations
22 heretofore or hereafter made, there is hereby appropriated
23 \$30,000 from the Alabama Behavior Analyst Licensing Board Fund
24 to the Alabama Behavior Analyst Licensing Board for the fiscal
25 year ending September 30, 2019.

1 Section 4. This act shall become effective
2 immediately upon its passage and approval by the Governor, or
3 upon its otherwise becoming law.
