1	amount of property tax reduction resulting from the homestead property tax

4	State shall submit a report to the President Pro Tempore of the Senate, the

18	homestead property tax credit, is amended to read as follows:		
19	(a)(l)(A) There is established a homestead property tax credit for		
20	each assessment year that reduces the amount of real property taxes assessed		
21	on the homestead of each property owner by four hundred twenty-five dollars		
22	(\$425) five hundred dollars (\$500).
