1 "Concealed" means to cover from observation so as to prevent (1) 2 public view; 3 (2) "Convicted" means that a person pleaded guilty or nolo contendere 4 to or was found guilty of a criminal offense; 5 "Handgun" means any firearm, other than a fully automatic firearm, (3) 6 with a barrel length of less than twelve inches (12") that is designed, made, 7 or adapted to be fired with one (1) hand; and. 8 (4) "Higher education campus" means the grounds and buildings owned or 9 leased by a university, college, or community college; 10 (4)(5) "Licensee" means a person granted a valid license to carry a 11 concealed handgun pursuant to this subchapter -; and 12 (6) "Staff member" means a person who is not enrolled as a full-time 13 student at the university, college, or community college and is either 14 employed by the university, college, or community college full-time or is on 15 a nine-month appointment at the university, college, or community college as 16 a faculty member. 17 18 SECTION 3. Arkansas Code § 5-73-306(14), regarding the carrying of 19 concealed weapons in certain places, is amended to read as follows: 20 (14) Any kingergarten through grade twelve (K-12) school, college, 21 community college, or university campus building, or event, unless for the 22 purpose of participating in an authorized firearms-related activity; 23 24 SECTION 4. Arkansas Code § 5-73-306(18) and (19), regarding the 25 carrying of concealed weapons in certain places, is amended to read as 26 follows: 27 (18) Any place where a parade or demonstration requiring a permit is 28 being held, and the licensee is a participant in the parade or demonstration; 29 or 30 (19)(A) Any place at the discretion of the person or entity exercising 31 control over the physical location of the place by placing at each entrance 32 to the place a written notice clearly readable at a distance of not less than 33 ten feet (10') that "carrying a handgun is prohibited". 34 (B)(i) If the place does not have a roadway entrance, there 35 shall be a written notice placed anywhere upon the premises of the place.
