23	SECTION 4. EMERGENCY CLAUSE. It is found and determined	d by the General

26	effectiveness of this Act on July 1, 2012 is essential to the	operation of		
27	the agency for which the appropriations in this Act are provi	ded, and that in		
28	the event of an extension of the legislative session, the dela	ay in the		
29	effective date of this Act beyond July 1, 2012 could work irre	eparable harm		
30	upon the proper administration and provision of essential gove	<u>ernmental</u>		
31	programs. Therefore, an emergency is hereby declared to exist	and this Act		
32	being necessary for the immediate preservation of the public	peace, health		
33	and safety shall be in full force and effect from and after J	uly 1, 2012.
