20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Health Services Permit Agency for the 2014-2015 fiscal year, the following

36 SECTION 4. APPROPRIATION - DEVELOPMENTAL DISABILITIES PLANNING COUNCIL

1 - FEDERAL. There is hereby appropriated, to the Health Services Permit
 2 Agency, to be payable from the federal funds as designated by the Chief
 3 Fiscal Officer of the State, for personal services and operating expenses of
 4 the Health Services Permit Agency - Developmental Disabilities Planning
 5 Council - Federal for the fiscal year ending June 30, 2015, the following:

21 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 23 FORWARD. Any unexpended balance of funds generated by fees and fines pursuant
 24 to Arkansas Code 20-8-103 et. seq. deposited into the Miscellaneous Agencies
 25 Fund Account which remain at the close of each state fiscal year shall be
 26 carried forward to the next state fiscal year to be used for the same intent
 27 and purposes as set forth in law.

28 Any carry forward of unexpended balance funding as authorized herein, may
 29 be carried forward under the following conditions:

30 (1) Prior to June 30, ~~2014~~ 2015 the Agency shall by written statement set
 31 forth its reason(s) for the need to carry forward said funding to the
 32 Department of Finance and Administration Office of Budget;

33 (2) The Department of Finance and Administration Office of Budget shall
 34 report to the Arkansas Legislative Council all amounts carried forward by the
 35 September Arkansas Legislative Council or Joint Budget Committee meeting,
 36 which report shall include the name of the Agency, Board, Commission or

1 Institution and the amount of the funding carried forward, the program name
2 or line item, the funding source of that appropriation and a copy of the
3 written request set forth in (1) above;

4 (3) Each Agency, Board, Commission or Institution shall provide a written
5 report to the Arkansas Legislative Council or Joint Budget Committee
6 containing all information set forth in item (2) above, along with a written
7 statement as to the current status of the project, contract, purpose etc. for
8 which the carry forward was originally requested no later than thirty (30)
9 days prior to the time the Agency, Board, Commission or Institution presents
10 its budget request to the Arkansas Legislative Council/Joint Budget
11 Committee; and

12 (4) Thereupon, the Department of Finance and Administration shall include
13 all information obtained in item (3) above in the budget manuals and/or a
14 statement of non-compliance by the Agency, Board, Commission or Institution.

15 The provisions of this section shall be in effect only from July 1, ~~2013~~
16 2014 through June 30, ~~2014~~ 2015.

17
18 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
19 authorized by this act shall be limited to the appropriation for such agency
20 and funds made available by law for the support of such appropriations; and
21 the restrictions of the State Procurement Law, the General Accounting and
22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
23 Procedures and Restrictions Act, or their successors, and other fiscal
24 control laws of this State, where applicable, and regulations promulgated by
25 the Department of Finance and Administration, as authorized by law, shall be
26 strictly complied with in disbursement of said funds.

27
28 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
29 Assembly that any funds disbursed under the authority of the appropriations
30 contained in this act shall be in compliance with the stated reasons for
31 which this act was adopted, as evidenced by the Agency Requests, Executive
32 Recommendations and Legislative Recommendations contained in the budget
33 manuals prepared by the Department of Finance and Administration, letters, or
34 summarized oral testimony in the official minutes of the Arkansas Legislative
35 Council or Joint Budget Committee which relate to its passage and adoption.

1 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
2 Assembly, that the Constitution of the State of Arkansas prohibits the
3 appropriation of funds for more than a one (1) year period; that the
4 effectiveness of this Act on July 1, 2014 is essential to the operation of
5 the agency for which the appropriations in this Act are provided, and that in
6 the event of an extension of the legislative session, the delay in the
7 effective date of this Act beyond July 1, 2014 could work irreparable harm
8 upon the proper administration and provision of essential governmental
9 programs. Therefore, an emergency is hereby declared to exist and this Act
10 being necessary for the immediate preservation of the public peace, health
11 and safety shall be in full force and effect from and after July 1, 2014.
