19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code Title 20, Chapter 77, Subchapter 1, is
22	amended to add an additional section to read as follows:
23	20-77-135. Prohibition of cost-settlement reimbursement.
24	(a) As used in this section:
25	(1) "Cost-settlement reimbursement" means reimbursement of
26	reasonable costs that are actually incurred by a healthcare provider within a
27	child health management services program or any successor program providing
28	early intervention day treatment services to children or the rehabilitative
29	services for persons with mental illness program or any successor program
30	providing adult developmental day treatment services in order to provide a
31	healthcare service to the extent that the costs are necessary to efficiently
32	deliver that service and the costs are in excess of the reimbursement for the
33	healthcare service;
34	(2) "Governmental body" means any office, department,
35	commission, council, board, committee, legislative body, agency, or other
36	establishment of the executive, judicial, or legislative branch of the state,

1	municipality, county, school district, improvement district, or any political
2	district or subdivision thereof;
3	(3) "Private company" means a healthcare provider or entity that
4	is not a state agency or governmental body; and
5	(4) "State agency" means any office, department, board,
6	commission, bureau, division, public corporation, agency, institution of
7	higher learning, or instrumentality of this state.
8	(b) The Arkansas Medicaid Program is prohibited from providing cost-
9	settlement reimbursement to a Medicaid provider that is a private company.
10	(c) This section does not apply to other healthcare services that are
11	not child health management services, including early intervention day
12	treatment services, or rehabilitative services for a person with mental
13	illness, including adult developmental day treatment services.
