22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

2 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FEDERAL
4 MATCHING. The funds appropriated in Sections for Adult Basic and General
5 Adult Education, Coordinated Career Education Services, Vocational Center Aid
6 and Vocational Start-up Grants and Aid of this Act may also be used to match
7 any available federal funds from any agency in order to provide the maximum
8 amount of money possible for the purposes enumerated in such section.

9 The provisions of this section shall be in effect only from July 1,
10 ~~2010~~ 2011 through June 30, ~~2011~~ 2012.

12 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
14 VOCATIONAL START-UP. The funds and appropriations contained herein for
15 Vocational Start-Up shall be allocated in accordance with rules and
16 regulations established by the State Board of Career Education, after the
17 rules and regulations have undergone a prior review by the Administrative
18 Rules and Regulations Subcommittee of the Arkansas Legislative Council or
19 Joint Budget Committee.

20 The provisions of this section shall be in effect only from July 1,

23 SECTION 22. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
24 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
25 EDUCATIONAL TRAINING/RETRAINING. Of the funds and appropriation authorized by
26 Item (01) in the section of this Act for Adult Basic and General Adult
27 Education, a sum of \$300,000 each fiscal year shall be made available to
28 eligible entities approved by the State Board of Career Education, in order
29 to expand the vocational education and training opportunities available to
30 area citizens in need of adult educational training or retraining due to
31 changing technology.

32 Further, if the appropriation is not fully funded due to a decrease in
33 the official revenue forecast or the available carryover balance of the
34 Department of Workforce Education Public School Fund Account, the Department
35 of Career Education may reduce proportionally the amount made available to
36 eligible entities approved by the State Board of Career Education in order to

1 expand the vocational education and training opportunities to area citizens
2 in need of adult educational training or retraining due to changing
3 technology.

4 The provisions of this section shall be in effect only from July 1,
5 ~~2010~~ 2011 through June 30, ~~2011~~ 2012.

6
7 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ADULT
9 EDUCATION DISTRIBUTION. All funds that become available for Adult Education
10 shall ~~first~~ be distributed to those administrative units determined to be
11 operating efficient and effective adult education programs, under criteria
12 established by the State Board of Career Education. The criteria shall
13 include the relative efficiency of administration of the program in the
14 counties served and achievement of federal performance indicators. The State
15 Board of Career Education shall promulgate rules and regulations for the
16 distribution of funds in accordance with criteria to be determined by the
17 Board. In the distribution of funds to local units the Board shall consider
18 ~~the literacy rate in each county and~~ performance in meeting state and federal
19 performance indicators. ~~For the purposes of this Section, the term "literacy~~
20 ~~rate" shall be determined by the number of adults completing less than the~~
21 ~~twelfth grade as reported by the most recent decennial federal census.~~
22 Unallocated funds will be redistributed based upon need as determined by the
23 State Board of Career Education.

24 The provisions of this section shall be in effect only from July 1,
25 ~~2010~~ 2011 through June 30, ~~2011~~ 2012.

26
27 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
29 OF FUNDS – PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall
30 establish, upon request from the Department of Career Education, a special
31 appropriation line item to be used in the acquisition of promotional items.
32 When the Department of Career Education wishes to transfer monies from its
33 operating expenses appropriation to the Promotional Items line, the State
34 Board of Career Education shall approve the request and forward it after
35 receiving prior review and approval by the Arkansas Legislative Council or
36 Joint Budget Committee, to the Chief Fiscal Officer of the State for

1 processing.

2 Determining the maximum number of employees and the maximum amount of
3 appropriation and general revenue funding for a state agency each fiscal year
4 is the prerogative of the General Assembly. This is usually accomplished by
5 delineating such maximums in the appropriation act(s) for a state agency and
6 the general revenue allocations authorized for each fund and fund account by
7 amendment to the Revenue Stabilization law. Further, the General Assembly
8 has determined that the Department of Career Education may operate more
9 efficiently if some flexibility is provided to the Department of Career
10 Education authorizing broad powers under this Section. Therefore, it is both
11 necessary and appropriate that the General Assembly maintain oversight by
12 requiring prior approval of the Legislative Council or Joint Budget Committee
13 as provided by this section. The requirement of approval by the Legislative
14 Council or Joint Budget Committee is not a severable part of this section.
15 If the requirement of approval by the Legislative Council or Joint Budget
16 Committee is ruled unconstitutional by a court of competent jurisdiction,
17 this entire section is void.

18

19 SECTION 25. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
20 authorized by this act shall be limited to the appropriation for such agency
21 and funds made available by law for the support of such appropriations; and
22 the restrictions of the State Procurement Law, the General Accounting and
23 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
24 Procedures and Restrictions Act, or their successors, and other fiscal
25 control laws of this State, where applicable, and regulations promulgated by
26 the Department of Finance and Administration, as authorized by law, shall be
27 strictly complied with in disbursement of said funds.

28

29 SECTION 26. LEGISLATIVE INTENT. It is the intent of the General
30 Assembly that any funds disbursed under the authority of the appropriations
31 contained in this act shall be in compliance with the stated reasons for
32 which this act was adopted, as evidenced by the Agency Requests, Executive
33 Recommendations and Legislative Recommendations contained in the budget
34 manuals prepared by the Department of Finance and Administration, letters, or
35 summarized oral testimony in the official minutes of the Arkansas Legislative
36 Council or Joint Budget Committee which relate to its passage and adoption.

1
2 SECTION 27. EMERGENCY CLAUSE. It is found and determined by the
3 General Assembly, that the Constitution of the State of Arkansas prohibits
4 the appropriation of funds for more than a one (1) year period; that the
5 effectiveness of this Act on July 1, 2011 is essential to the operation of
6 the agency for which the appropriations in this Act are provided, and that in
7 the event of an extension of the legislative session, the delay in the
8 effective date of this Act beyond July 1, 2011 could work irreparable harm
9 upon the proper administration and provision of essential governmental
10 programs. Therefore, an emergency is hereby declared to exist and this Act
11 being necessary for the immediate preservation of the public peace, health
12 and safety shall be in full force and effect from and after July 1, 2011.
