3	SECTION 2. Arkansas Code § 12-60-103 is amended to read as follows:
4	12-60-103. Persons subject to the code.
5	The following persons who are not in federal service are subject to
6	this code:
7	(1) Members of the organized militia.
8	(2) All other persons lawfully ordered to \underline{a} duty \underline{status} in or
9	with the organized militia, including the Army National Guard, Air National
10	Guard, the Arkansas Guard, and all persons ordered to \underline{a} duty \underline{status} in or
11	with any of the foregoing from the dates they are required by the terms of
12	the order or other directive to obey the code.
13	
14	SECTION 3. Arkansas Code § 12-62-302(b), concerning pay and allowances
15	for service on boards, commissions, and courts, is amended to read as
16	follows:
17	(b) The pay shall be the same as for officers and enlisted personnel
18	of the armed forces of the United States of equal grade, rating, and length
19	of service, or at a flat daily rate of forty dollars (\$40.00) for each day of
20	twenty-four (24) hours or less actually spent on active duty, whichever is
21	greater.
22	
23	SECTION 4. Arkansas Code § 12-64-102(a), concerning the military
24	justice jurisdiction to try certain personnel, is amended to read as follows:
25	(a) Jurisdiction of courts-martial shall be coextensive with the
26	jurisdiction provided for similar courts of the United States Army and United
27	States Air Force while accounting for the differences in the types of duty
28	status of members of the organized militia.
29	
30	SECTION 5. Arkansas Code § 12-64-401 is amended to read as follows:
31	12-64-401. Classifications of courts-martial.
32	There shall be three (3) kinds of courts-martial in each of the forces
33	of the organized militia, namely:
34	(1) General courts-martial, which shall consist of:
35	(A) A military judge and <u>:</u>
36	(i) any Any number of members not less than five (5)

1	eight (8); or
2	(ii) Six (6) or seven (7) members if after
3	impanelment as required by subdivision (1)(A)(i) of this section there are

17	subject to applicable limitations; and
18	(3) Summary courts-martial which shall consist of one (1) officer.

20	SECTION 6. Arkansas Code § 12-64-402(a), concerning court-martial
21	jurisdiction, is amended to read as follows:
22	(a) Each force of the organized militia has court-martial jurisdiction
23	and powers over all persons subject to this code and shall follow the forms
24	and procedures provided for similar courts of the United States Army and
25	United States Air Force unless specifically enumerated in the Arkansas Code
26	or by the Governor as the chief executive officer and Commander-in-Chief of
27	the organized militia.
28	
29	SECTION 7. Arkansas Code § 12-64-403 is amended to read as follows:
30	12-64-403. General courts-martial punishments.
31	General courts-martial may, under such limitations as the Governor may
32	prescribe, adjudge one (1) or more of the following punishments <u>for each</u>
33	specification:
34	(1) A fine or forfeiture in an amount that shall not exceed two
35	hundred (200) days of the service member's base pay and allowances
36	Confinement with hard labor that shall not exceed the lowest sentence

Arkansas Code § 12-64-405(c), concerning summary courts-33 martial punishments, is amended to read as follows: 34 (c) A summary court-martial may, under such limitations as the 35 Governor may prescribe, adjudge one (1) or more of the following punishments:

15	personally has requested in writing that enlisted members serve on it.
16	
17	SECTION 11. Arkansas Code § 12-64-410(c), concerning trial and defense
18	counsel, is amended to add an additional subsection to read as follows:
19	(c)(1) If a victim of a crime committed subject to this code has a
20	special victims' counsel provided at the expense of an appropriate government
21	agency, the special victims' counsel shall be afforded all of the rights and
22	privileges offered to counsel at similar courts of the United States Army and
23	the United States Air Force.
24	(2) A judge advocate certified to practice before military
25	courts is fully certified and qualified to serve as a special victims'
26	counsel for the courts convened under this code, without regard to the judge
27	advocate's licensing state.
28	(3) Any counsel furnished at the expense of the United States
29	Government or the state government shall be qualified to serve as a special
30	victims' counsel under this section and, if qualified, shall be exempt from
31	any fees or additional requirements.
32	
33	SECTION 12. Arkansas Code § 12-64-411, concerning court reporters and
34	interpreters, is amended to add an additional subsection to read as follows:
35	(c) Under like regulations, the convening authority of a general or

special court-martial shall detail a military court clerk who shall serve in

1	that role in any appeal prescribed by § 12-64-714.
2	
3	SECTION 13. Arkansas Code § 12-64-414(b) and (c), concerning courts-
4	martial absent and additional members, are amended to read as follows:
5	(b)(1) Whenever a general court-martial is reduced below $\frac{\text{five (5)}}{\text{six}}$
6	(6) members, the trial may not proceed unless the convening authority details
7	new members sufficient in number to provide not less than $\frac{\text{five (5)}}{\text{six (6)}}$
8	members.
9	(2) When the new members have been sworn, the trial may proceed
10	after the recorded testimony of each witness previously examined has been
11	read to the court in the presence of the military judge, the accused, and the
12	counsel.
13	(c)(1) Whenever a special court-martial is reduced below three (3)
14	$\underline{\text{four (4)}}$ members, the trial may not proceed unless the convening authority
15	details new members sufficient in number to provide not less than three (3)

17	(2) When the new members have been sworn, the trial shall

22	SECTION 14. Arkansas Code § 12-64-504 is amended to read as follows:
23	12-64-504. Investigation.
24	(a)(1) No charge or specification may be referred to a general court-
25	martial for trial until a thorough and impartial investigation of all the
26	matters set forth therein has been made.
27	(2) This investigation shall include inquiry as to the truth of
28	the matter set forth in the charges, consideration of the form of charges,
29	and a recommendation as to the disposition which should be made of the case
30	in the interest of justice and discipline.
31	(b)(1) The accused shall be advised of the charges against him or her

(2) Upon his or her own request, he or she shall be represented by civilian counsel if provided by him or her or military counsel of his or her own selection if such counsel is reasonably available or by counsel detailed by the officer exercising general court martial jurisdiction over

27	hearing is not required if the accused submits a written waiver of the
28	preliminary hearing to the convening authority and the convening authority
29	grants the waiver.
30	(2) The purpose of the preliminary hearing shall be limited to
31	determining the following:
32	(A) Whether or not the specification alleges an offense
33	under this chapter;
34	(B) Whether or not there is probable cause to believe that
35	the accused committed the offense charged;

(C) Whether or not the convening authority has court-

1	martial jurisdiction over the accused and over the offense; and
2	(D) A recommendation as to the disposition that should be
3	made of the case.
4	(3) The rights of the accused and the rights of the victim shall
5	be the same as provided under 10 U.S.C § 832 et seq., as it existed on

8	SECTION 15. Arkansas Code § 12-64-507(a), concerning service of
9	charges for a court-martial, is amended to read as follows:
10	(a) The trial counsel to whom court-martial charges are referred for
11	trial shall cause to be served upon the accused, or the defense counsel, a
12	copy of the charges upon which trial is to be held.
13	
14	SECTION 16. Arkansas Code § 12-64-508 is amended to read as follows:
15	12-64-508. Procedural rules.
16	The procedures used by general, special, and summary courts-martial
17	shall be the same <u>similar</u> as <u>to</u> those established by the United States
18	Congress for similar courts of the United States Army and United States Air
19	Force; however, the Governor has executive authority over the military courts
20	of the organized militia and may implement state-specific procedural rules
21	when necessary and practical.
22	
23	SECTION 17. Arkansas Code § 12-64-523 is amended to read as follows:
24	12-64-523. Convictions, sentences, etc. — Number of votes required.
25	(a) No person may be convicted of an offense except by the concurrence
26	of two-thirds (2/3) three-fourths ($\frac{3}{4}$) of the members present at the time the
27	vote is taken.
28	(b) All sentences shall be determined by the concurrence of $\frac{1}{1}$
29	$\frac{(2/3)}{(2/3)}$ three-fourths $(\frac{3}{4})$ of the members present at the time that the vote is
30	taken.
31	(c) All other questions to be decided by the members of a general or
32	special court-martial shall be determined by a majority vote.
33	(d)(1) A tie vote on a challenge disqualifies the member challenged.

6	A court-martial shall announce its findings and sentence to the parties

8	(a) In all trials, the court-martial shall announce a finding for each	
9	charge and specification that is not dismissed or withdrawn by the	
10	prosecution to the parties as soon as the findings are determined.	
11	(b) In all trials before members, the court-martial shall announce a	
12	single sentence as to confinement, fines or forfeitures, discharge or	
13	dismissal, and reprimand and reduction in rank for all charges and	
14	specifications for which the accused was found guilty.	
15	(c) In all trials before a judge alone, the court-martial shall	
16	announce a separate sentence as to confinement, fines or forfeitures,	
17	discharge or dismissal, and reprimand and reduction in rank for each charge	
18	and specification for which the accused was found guilty.

20	SECTION 19. Arkansas Code § 12-64-714(c), concerning appeals, is

23	shall be lodged in the office of the clerk of the court within the time	
24	prescribed by law or court rule for filing an appeal of a criminal conviction	
25	in a circuit court in this state, and not thereafter, and only after the	
26	party appealing has paid to the Adjutant General the costs for preparation of

27	reporting or planning to report a criminal offense, or with the intent to
28	discourage any person from reporting a criminal offense:
29	(1) Wrongfully takes or threatens to take adverse personnel
30	action against any person; or
31	(2) Wrongfully withholds or threatens to withhold a favorable
32	personnel action with respect to any person.

34	12-64-850. Fraudulent use of credit cards, debit cards, and other

36	A person subject to this code shall be punished as a court-martial may

17	(2) Engages in prohibited sexual activity with the specially
18	protected junior member of the armed forces.

29	SECTION 23. EMERGENCY CLAUSE. It is found and determined by the
30	General Assembly of the State of Arkansas that the removal of officers who
31	are substandard in performance of duty or in conduct, deficient in character,
32	or unsuited for military service is of paramount importance to the good order
33	and discipline of the Arkansas National Guard and security of the State of
34	Arkansas. Therefore, an emergency is declared to exist, and this act being
35	immediately necessary for the preservation of the public peace, health, and
36	safety shall become effective on:

1	(1) The date of its approval by the Governor;
2	(2) If the bill is neither approved nor vetoed by the Governor,
3	the expiration of the period of time during which the Governor may veto the
4	bill; or
5	(3) If the bill is vetoed by the Governor and the veto is
6	overridden, the date the last house overrides the veto.
