30	agencies listed herein shall have the authority to accept and use grants and
31	donations including Federal funds, and to use its unobligated cash income or
32	funds, or both available to it, for the purpose of supplementing the State
33	Treasury funds for financing the entire costs of the project or projects
34	enumerated herein. Provided further, that the appropriations and funds
35	otherwise provided by the General Assembly for Maintenance and General
36	Operations of the agency or institutions receiving appropriation herein shall

1 not be used for any of the purposes as appropriated in this act. 2 (B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the 3 4 Revenue Stabilization Law and any other applicable fiscal control laws of 5 this State and regulations promulgated by the Department of Finance and 6 Administration, as authorized by law, shall be strictly complied with in 7 disbursement of any funds provided by this act unless specifically provided 8 otherwise by law. 9 10 SECTION 26. LEGISLATIVE INTENT. It is the intent of the General 11 Assembly that any funds disbursed under the authority of the appropriations 12 contained in this act shall be in compliance with the stated reasons for 13 which this act was adopted, as evidenced by the Agency Requests, Executive 14 Recommendations and Legislative Recommendations contained in the budget 15 manuals prepared by the Department of Finance and Administration, letters, or 16 summarized oral testimony in the official minutes of the Arkansas Legislative 17 Council or Joint Budget Committee which relate to its passage and adoption. 18 19 SECTION 27. EMERGENCY CLAUSE. It is found and determined by the 20 General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the 21 22 effectiveness of this Act on July 1, 2023 is essential to the operation of 23 the agency for which the appropriations in this Act are provided, and that in 24 the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2023 could work irreparable harm 25 26 upon the proper administration and provision of essential governmental 27 programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health 28 29 and safety shall be in full force and effect from and after July 1, 2023. 30 31 32 33 34 35
