19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. Arkansas Code § 17-103-205 is amended to read as follows:  
22 17-103-205. Fees.

23 The Arkansas Social Work Licensing Board shall establish, charge, and  
24 collect for:

25 (1) The filing of an application for a license under this  
26 chapter, a nonrefundable fee of not more than ~~fifty dollars (\$50.00)~~ one  
27 hundred dollars (\$100);

28 ~~(2) The taking of an examination, a fee as established by~~  
29 ~~regulation of the board;~~

30 ~~(3) The original issuance of a license under this chapter, a fee~~  
31 ~~of not more than fifty dollars (\$50.00);~~

32 ~~(4)~~(2) A nonrefundable renewal of a license issued in accordance  
33 with this chapter, a fee of not more than eighty dollars (\$80.00);

34 ~~(5)~~(3) Replacement of a license ~~or renewal lost or destroyed~~, a  
35 nonrefundable fee of not less than twenty dollars (\$20.00); ~~and~~

36 ~~(6)~~(4) Endorsement of a ~~foreign~~ Arkansas social work license,



1 a nonrefundable fee of twenty dollars (\$20.00);

2 (5) Renewal of a license after the expiration date, a  
3 nonrefundable late fee of not more than eighty dollars (\$80.00);

4 (6) A criminal background check processing fee, the fee amount  
5 to be determined by the Department of Arkansas State Police;

6 (7) The filing of an application for a certificate of  
7 registration under this chapter, a nonrefundable fee of not more than twenty-  
8 five dollars (\$25.00); and

9 (8) Renewal of a certificate of registration issued under this  
10 chapter, a nonrefundable fee of not more than ten dollars (\$10.00).
