1	accessible list on its website of any person convicted of an animal abuse	
2	offense.	
3	(2)(A) The list under subdivision (a)(l) of this section shall	
4	include a photograph taken of the person, the person's full legal name, and	
5	other identifying data as the center determines is necessary to properly	
6	identify the person and to exclude innocent persons.	
7	(B) The list under subdivision (a)(l) of this section shall	
8	not include the person's Social Security number, driver's license number, or	
9	any other state or federal identification number.	
10	(b) A circuit court clerk shall forward a copy of the sentencing order	
11	and date of birth of a person convicted of an animal abuse offense to the	
12	center within sixty (60) calendar days of the date of the sentencing order.	
13	(c)(1) Upon a person's first conviction for an animal abuse offense,	
14	the center shall maintain the person's name and other identifying	
15	information, described in subdivision (a)(2)(A) of this section on the list	
16	under subdivision (a)(l) of this section published for two (2) years	
17	following the date of conviction, after which time the center shall remove	
18	the person's name and identifying information from the list if the	
19	person is not convicted of another animal abuse offense during that two-year	
20	period.	
21	(2) Upon a person's subsequent conviction for an animal abuse	
22	offense, the center shall maintain the person's name and other identifying	
23	information, described in subdivision (a)(2)(A) of this section on the list	
24	under subdivision (a)(l) of this section for five (5) years following the	
25	date of the most recent conviction, after which time the center shall remove	
26	the person's name and identifying information from the list if the person is	
27	not convicted of another animal abuse offense during that five-year period.	
28	(d) The center shall remove the person's name and identifying	
29	information from the list under subdivision (a)(1) of this section if the	
30	sole offense for which the person is required to be subject to the mandates	
31	of the registry is sealed under the Comprehensive Criminal Record Sealing Act	
32	of 2013, § 16-90-1401 et seq., or pardoned.
