17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18

19 SECTION 1. Arkansas Code Title 27, Chapter 24, Subchapter 14, is
20 amended to add an additional section to read as follows:

21 27-24-1411. Hispanic Americans.

22 (a)(1) The Director of the Department of Finance and Administration
23 shall issue a special license plate in honor of Hispanic Americans in the
24 manner and subject to the conditions provided for under this subchapter.

25 (2) The procedures concerning costs for issuance under § 27-24-
26 1404(c)(1)(A) shall apply.

27 (b) The Hispanic Americans motor vehicle special license plate shall
28 be:

29 (1)(A) Designed by the Arkansas Martin Luther King, Jr.
30 Commission.

31 (B) The design shall be submitted for design approval by
32 the director under rules promulgated by the director; and

33 (2) Numbered consecutively.

34 (c) The Department of Finance and Administration shall issue a special
35 license plate under this section upon payment of:

36 (1) The fee required by law for registration of the motor



1 vehicle;

2 (2)(A) Fifty dollars (\$50.00) to cover the design-use
 3 contribution.

4 (B) The design-use contribution shall be remitted monthly
 5 to the commission to be used for commission purposes; and

6 (3)(A) A handling and administrative fee of ten dollars
 7 (\$10.00).

8 (B) The handling and administrative fee shall be:

9 (i) Deposited into the State Central Services Fund
 10 for the benefit of the Revenue Division of the Department of Finance and
 11 Administration; and

12 (ii) Credited to the division as supplemental and in
 13 addition to all other funds that may be deposited for the benefit of the
 14 division.

15 (C) The handling and administrative fee shall not be
 16 considered or credited to the division as direct revenue.

17 (d)(1) A special license plate issued under this section may be
 18 renewed annually or replaced under the procedures set out in § 27-24-1405.

19 (2) However, the division shall remit the fees collected under §
 20 27-24-1405(b)(2) on a monthly basis to the commission.

 22 SECTION 2. EFFECTIVE DATE. This act is effective on and after January
 23 1, 2014.
