20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code § 20-9-214(b), concerning fees for issuance  
23 of licensure by the Department of Health, is amended to read as follows:

24 (b) The Department of Health may levy and collect the following annual
