1	As used in this chapter:
2	(1)(A) "Amateur sport or athletic event" means an athletic or
3	sports event involving at least two (2) competitors who do not receive
4	compensation, in excess of their expenses, for participating in the event.
5	(B) "Amateur sport or athletic event" does not include
6	events in which the majority of participants are under eighteen (18) years of
7	age;
8	(2) "Casino licensee" means a person holding a license to
9	conduct casino gaming pursuant to The Arkansas Casino Gaming Amendment of
10	2018, Arkansas Constitution, Amendment 100;
11	(3) "Collegiate sport or athletic event" means an athletic or
12	sport event involving a sports or athletics team of a public or private
13	institution of higher education;
14	(4) "Online sports pool" means an operation in which wagers on
15	sports events are made over the internet on websites or mobile applications
16	through computers, mobile devices, or other approved interactive devices
17	accepted through a gaming system approved by the Arkansas Racing Commission;
18	(5) "Online sports pool platform" means an integrated system of
19	hardware, software or applications through which an online sports pool
20	operator operates, conducts, or offers an online sports pool;
21	(6) "Online sports pool operator" means a:
22	(A) Casino licensee that has elected to operate an online
23	sports pool; or
24	(B) Sports pool operator intermediary operating an online
25	sports pool on behalf of a casino licensee;
26	(7) "Online sports pool system" means all hardware, software,
27	and communications that comprise a type of server-based gaming system for the
28	purpose of offering an online sports pool;
29	(8)(A) "Professional sport or athletic event" means an athletic
30	or sport event involving at least two (2) competitors who receive
31	compensation, in excess of their expenses, for participating in the event.
32	(B) "Professional sport or athletic event" includes the
33	conduct of sports events or tournaments in which the winning player or
34	winning players or winning team or winning teams receive compensation, in
35	excess of their expenses, for participating in the event, whether or not
36	every individual participant in the event or tournament receives compansation

1	in excess of his or her expenses;
2	(9) "Service industry license" means a license issued by the
3	commission to an entity to provide goods or services, or both, to a casino
4	licensee;
5	(10) "Sports event" means any professional sport or athletic
6	event, amateur sport or athletic event, collegiate sport or athletic event,
7	motor race event, electronic sports event, competitive video game event, or
8	any other event authorized by the commission;
9	(11) "Sports pool operator intermediary" means an independent
10	entity holding a service industry license that supplies or offers services
11	through an online sports pool in conjunction with a casino licensee; and
12	(12) "Sports wagering account" means an account established by
13	an online sports pool operator for an individual patron to use for online
14	sports pool wagering.
15	
16	<u>23-118-103.</u> Rules.
17	(a) The Arkansas Racing Commission shall promulgate rules to implement
18	this chapter, including without limitation:
19	(1) The types of wagers that may be offered and events that may
20	be wagered on;
21	(2) Geolocation requirements;
22	(3) Reporting and record-keeping requirements;
23	(4) Responsible gaming requirements; and
24	(5) Advertising requirements that prohibit the direct targeting
25	of minors or self-excluded persons.
26	(b) When promulgating rules under this chapter, the commission shall:
27	(1) Examine the rules and regulations implemented in states
28	where sports wagering is conducted; and
29	(2) Adopt, as far as is practicable, a similar framework.
30	
31	23-118-104. Limitations on licensed online sports pools.
32	(a) Each casino licensee may provide no more than three (3)
33	individually branded online sports pool platforms, which may be operated by
34	the casino licensee or by sports pool operator intermediaries.
35	(b)(1) All wagers on sports events shall be initiated, received, and
36	otherwise made within this state unless otherwise permitted by the Arkansas

1	Racing Commission in accordance with applicable federal and state laws.
2	(2) Consistent with the intent of the United States Congress as
3	articulated in the Unlawful Internet Gambling Enforcement Act of 2006, 31
4	U.S.C. § 5361 et seq., as it existed on January 1, 2021, the intermediate
5	routing of electronic data relating to a lawful intrastate wager authorized
6	under this section shall not determine the location or locations in which the
7	wager is initiated, received, or otherwise made.
8	
9	23-118-105. Approval to immediately commence online sports pool
10	operations.
11	(a)(1) Upon receiving an application from a casino licensee to operate
12	an online sports pool, the Arkansas Racing Commission shall review the
13	request.
14	(2) If the commission determines that the applicant holds a
15	valid casino license and is in compliance with this chapter, the commission
16	shall immediately authorize the casino licensee to operate an online sports
17	pool.
18	(b)(1) Any sports pool operator intermediary seeking to operate an
19	online sports pool pursuant to a contract with the casino licensee is
20	required to be licensed by the commission as a service industry licensee.
21	(2) Upon submitting an application and an application fee to the
22	commission for a service industry license, an applicant may submit a
23	contemporaneous request to the commission for an interim license authorizing
24	the applicant to immediately act as a sports pool operator intermediary for
25	up to three hundred sixty-five (365) days, pending the commission's full
26	review of the application for the service industry license.
27	(3) All online sports pool wagering conducted under authority of
28	an interim license approval under subdivision (b)(2) of this section shall
29	comply with this chapter and any applicable rules of the commission related
30	to sports wagering.
31	(c)(1) The commission may approve certain system, network,
32	operational, and other standards necessary to implement online sports pool
33	wagering on a temporary basis if a deadline for full-compliance with
34	permanent standards is provided at the time of approval.
35	(2) Extensions may be approved by the commission if

justification is provided to show that the additional time in the temporary

1	environment is reasonably necessary.
2	(d) Online sports pools conducted in compliance with this chapter are
3	exempt from § 5-66-101 et seq.
4	
5	23-118-106. Sports wagering accounts.
6	(a) Online sports pool wagering shall only be engaged in by patrons
7	who have established a sports wagering account.
8	(b) A patron may establish and fund his or her sports wagering
9	account:
10	(1) In person at the location of the casino licensee; or
11	(2) Remotely over the internet with the online sports pool
12	operator through the online sports pool operator's online sports pool system.
13	
14	SECTION 2. DO NOT CODIFY. TEMPORARY LANGUAGE.
15	The Arkansas Racing Commission shall:
16	(1) Adopt rules to implement this act within ninety (90) days of
17	the effective date of this act; and
18	(2) Repeal or amend any existing rules that are in conflict with
19	this act.
