21	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL
22	ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Section 54.(c)(1) of the Rules of the House of
25	Representatives of the Ninety-Third General Assembly, which pertains to
26	appointment of a chairperson and vice chairperson for committees of the House
27	of Representatives, is amended to read as follows:
28	54.(c)(1)(A) The Speaker of the House of Representatives shall appoint
29	a chairperson and a vice chairperson of each standing committee and each
30	select committee who shall serve at the pleasure of the Speaker of the House
31	of Representatives.
32	(B) The Speaker, in consultation with the chairperson of each
33	standing committee, shall appoint from the membership of each permanent
34	subcommittee, a chairperson and vice chairperson, provided, however, that the
35	vice chairperson of the standing committee may be the chairperson of a
36	permanent subcommittee.



1	(C) The House Minority Leader shall appoint from the minority
2	party leadership on each standing committee one (1) minority party member to
3	serve as the shadow chairperson of the standing committee and one (1)
4	minority party member to serve as the shadow vice chairperson of the standing
5	committee. The shadow chairperson and shadow vice chairperson shall be
6	considered to be next in line in seniority to the chairperson and vice
7	chairperson only for purposes of the standing committee on which he or she
8	serves.
9	(D) No member of the House of Representatives, with the
10	exception of each House standing committee vice chairperson, shall be
11	chairperson or vice chairperson of more than one (1) standing committee,
12	select committee, or permanent subcommittee.
