21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
24 for the University of Arkansas at Pine Bluff for the 2012-2013 fiscal year,
25 the following maximum number of regular employees.

23 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 24 the University of Arkansas at Pine Bluff for the 2012-2013 fiscal year, the
 25 following maximum number of part-time or temporary employees, to be known as
 26 "Extra Help", payable from funds appropriated herein for such purposes: nine
 27 hundred twenty-four (924) temporary or part-time employees, when needed, at
 28 rates of pay not to exceed those provided in the Uniform Classification and
 29 Compensation Act, or its successor, or this act for the appropriate
 30 classification.

32 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby
 33 appropriated, to the University of Arkansas at Pine Bluff, to be payable from
 34 the University of Arkansas at Pine Bluff Fund, for personal services and
 35 operating expenses of the University of Arkansas at Pine Bluff for the fiscal
 36 year ending June 30, 2013, the following:

5 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
7 ALLOWANCES. The Board of Trustees, after seeking prior review by the
8 Arkansas Legislative Council, may approve the employment of competent
9 scientists with extraordinary research capabilities to conduct research in
10 the Biomedical Research Center established at the University of Arkansas at
11 Pine Bluff. Further, that the Board of Trustees of the University of
12 Arkansas be authorized to approve salaries for scientists up to, but not to
13 exceed, one and one-half of that portion of the Distinguished Professor line
14 item maximum authorized by the General Assembly to be paid from University of
15 Arkansas at Pine Bluff funds.

16 The provisions of this section shall be in effect only from July 1, ~~2011~~
17 2012 through June 30, ~~2012~~ 2013.

18

19 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
20 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. JENKINS
21 CENTER. Of the funds appropriated in Section 3, the sum of \$252,558 for the
22 fiscal year shall be used to provide support to the Jenkins Center in Pine
23 Bluff. Provided, however, such funds shall be used to conduct and maintain a
24 University training program in cooperation with the Jenkins Center.
25 Provided, further, any reductions in funding for appropriation provided in
26 Section 3 shall be proportionately applied to the funds set out herein for
27 support.

28 The provisions of this section shall be in effect only from July 1, ~~2011~~
29 2012 through June 30, ~~2012~~ 2013.

31 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FORMULA
33 COMPUTATIONS – 1890 MATCHING FUNDS. Any computations made by the Department
34 of Higher Education and the Arkansas Higher Education Coordinating Board in
35 determining levels of recommended funding for the University of Arkansas at
36 Pine Bluff shall include 100% matching funds for the 1890 Research and

1 Extension Programs in the base.

2
3 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
4 authorized by this act shall be limited to the appropriation for such agency
5 and funds made available by law for the support of such appropriations; and
6 the restrictions of the State Procurement Law, the General Accounting and
7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
8 Procedures and Restrictions Act, the Higher Education Expenditures
9 Restrictions Act, or their successors, and other fiscal control laws of this
10 State, where applicable, and regulations promulgated by the Department of
11 Finance and Administration, as authorized by law, shall be strictly complied
12 with in disbursement of said funds.

13
14 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
15 Assembly that any funds disbursed under the authority of the appropriations
16 contained in this act shall be in compliance with the stated reasons for
17 which this act was adopted, as evidenced by the Agency Requests, Executive
18 Recommendations and Legislative Recommendations contained in the budget
19 manuals prepared by the Department of Finance and Administration, letters, or
20 summarized oral testimony in the official minutes of the Arkansas Legislative
21 Council or Joint Budget Committee which relate to its passage and adoption.

22
23 SECTION 10. EMERGENCY CLAUSE. It is found and determined by the
24 General Assembly, that the Constitution of the State of Arkansas prohibits
25 the appropriation of funds for more than a one (1) year period; that the
26 effectiveness of this Act on July 1, 2012 is essential to the operation of
27 the agency for which the appropriations in this Act are provided, and that in
28 the event of an extension of the legislative session, the delay in the
29 effective date of this Act beyond July 1, 2012 could work irreparable harm
30 upon the proper administration and provision of essential governmental
31 programs. Therefore, an emergency is hereby declared to exist and this Act
32 being necessary for the immediate preservation of the public peace, health
33 and safety shall be in full force and effect from and after July 1, 2012.
