16 SERVICES - DIVISION OF CHILDREN AND  
17 FAMILY SERVICES APPROPRIATION FOR THE

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established  
25 for the Department of Human Services - Division of Children and Family  
26 Services for the 2013-2014 fiscal year, the following maximum number of  
27 regular employees.

5 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for  
 6 the Department of Human Services - Division of Children and Family Services  
 7 for the 2013-2014 fiscal year, the following maximum number of part-time or  
 8 temporary employees, to be known as "Extra Help", payable from funds  
 9 appropriated herein for such purposes: sixty-five (65) temporary or part-  
 10 time employees, when needed, at rates of pay not to exceed those provided in  
 11 the Uniform Classification and Compensation Act, or its successor, or this  
 12 act for the appropriate classification.

14 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,  
 15 to the Department of Human Services - Division of Children and Family  
 16 Services, to be payable from the paying account as determined by the Chief  
 17 Fiscal Officer of the State, for personal services and operating expenses of  
 18 the Department of Human Services - Division of Children and Family Services  
 19 for the fiscal year ending June 30, 2014, the following:

12 SECTION 5. APPROPRIATION - TANF - FOSTER CARE. There is hereby  
13 appropriated, to the Department of Human Services - Division of Children and  
14 Family Services, to be payable from the paying account as determined by the  
15 Chief Fiscal Officer of the State, for grant payments of the Department of  
16 Human Services - Division of Children and Family Services - TANF - Foster  
17 Care for the fiscal year ending June 30, 2014, the following:

23 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
24 authorized by this act shall be limited to the appropriation for such agency  
25 and funds made available by law for the support of such appropriations; and  
26 the restrictions of the State Procurement Law, the General Accounting and  
27 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
28 Procedures and Restrictions Act, or their successors, and other fiscal  
29 control laws of this State, where applicable, and regulations promulgated by  
30 the Department of Finance and Administration, as authorized by law, shall be  
31 strictly complied with in disbursement of said funds.

32  
33 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General  
34 Assembly that any funds disbursed under the authority of the appropriations  
35 contained in this act shall be in compliance with the stated reasons for  
36 which this act was adopted, as evidenced by the Agency Requests, Executive

1 Recommendations and Legislative Recommendations contained in the budget  
2 manuals prepared by the Department of Finance and Administration, letters, or  
3 summarized oral testimony in the official minutes of the Arkansas Legislative  
4 Council or Joint Budget Committee which relate to its passage and adoption.  
5

6 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General  
7 Assembly, that the Constitution of the State of Arkansas prohibits the  
8 appropriation of funds for more than a one (1) year period; that the  
9 effectiveness of this Act on July 1, 2013 is essential to the operation of  
10 the agency for which the appropriations in this Act are provided, and that in  
11 the event of an extension of the legislative session, the delay in the  
12 effective date of this Act beyond July 1, 2013 could work irreparable harm  
13 upon the proper administration and provision of essential governmental  
14 programs. Therefore, an emergency is hereby declared to exist and this Act  
15 being necessary for the immediate preservation of the public peace, health  
16 and safety shall be in full force and effect from and after July 1, 2013.
